**NOTICE OF PROPOSED EMERGENCY ACTION  
SUBJECT: END OF LIFE OPTION ACT**

The Department of Developmental Services (DDS) is proposing to readopt emergency regulations pertaining to the implementation of the End of Life Option Act.

Government Code section 11346.1(a)(2) requires that, at least five (5) working days prior to submission of the proposed emergency action to the Office of Administrative Law (OAL), DDS provide a notice of proposed emergency action to every person who has filed a request for notice of regulatory action with DDS. After submission of the proposed emergency action to OAL, OAL shall allow interested persons five (5) calendar days to submit comments on the proposed emergency regulations as set forth in Government Code section 11349.6.

During this five-day period, OAL will consider public comments concerning the proposed emergency action, including the proposed regulations and the finding of emergency. For comments to be considered by OAL, the following conditions must be met: 1) comments must be submitted to OAL and DDS in writing. This includes submissions of comments by mail, fax, or email to the addresses or numbers provided below. OAL will confirm that a copy of a comment has been submitted to DDS prior to considering the comment; 2) comments must be submitted within five (5) calendar days after the date the proposed emergency action is posted on OAL's website; and 3) comments must contain a notation that they are submitted to OAL for consideration in connection with the proposed emergency action and identify the topic of the emergency action to which they relate.

Upon filing the proposed emergency regulations with OAL, OAL will have ten (10) calendar days within which to review and make a decision about whether to readopt the proposed emergency regulations. If approved, OAL will file the regulations with the Secretary of State, and the emergency regulations will be readopted for ninety days (90) days. Within the 90-day effective period, the Department will continue the regular rulemaking action, including a public comment period. The emergency regulations will remain in effect during this rulemaking action.

Attached to this Notice is the specific regulatory language of the proposed emergency action and Finding of Emergency.
