## TO INTERESTED PARTIES

The 2015 May Revision to the Governor's Budget proposed the closures of Fairview Developmental Center (FDC) and the General Treatment Area of Porterville Developmental Center (PDC GTA) by the end of 2021. Efforts are underway to develop a joint closure plan for FDC in Costa Mesa, CA and PDC GTA, which will be submitted to the Legislature by April 1, 2016, for review and approval.
