

November 14, 2017

1. CALL TO ORDER

Deaka McClain, Chairperson, called the meeting to order at 9:03am.



- c. The agenda was reviewed and no changes were made. It was moved (Jessica Gould), seconded (Lisa Utsey), and carried to approve the agenda with the changes.
- d. The minutes of the June 2017 CAC meeting were reviewed. It was moved (Esther Kelsey), seconded (Ryan Nelson), and carried to approve the minutes with changes.
- e. Deaka read the Ground Rules.



2. END OF LIFE

Nicole Patterson from DDS and Christie Hager from Disability Rights California (DRC) did a presentation on the End of Life CAC publication. DRC is talking about taking the publication and putting it into a training to help more people start having the conversation, and share their wishes and thoughts, on what End of Life looks like for them. They would like the CAC's input on the process.

 They reviewed the publication and received some feedback from the group.

- In Christine's region, people use this publication, tear out the back pages and put copies in their IPPs at the regional center.
- Condensing the publication might be helpful to people. Christine stressed the importance of working on this publication in several sessions so it's not so overwhelming.
- This document can be used for anyone, not just people with disabilities.
- DRC will train their Clients Rights Advocates to start talking to each regional center to have this included in IPPs.
- A good strategy could be for members to start talking about it.
- ANYONE you trust can help you with this process.
 It doesn't have to be family or next of kin.
- If you are conserved, please have the conversation with your conservators.
- If your conservator has control over your end of life choices in your legal documents, there are steps you can take.
- People need to be educated about this publication and made aware of their rights.



3. FACILITATION PRESENTATION AND DISCUSSION

Lisa Utsey did a presentation on facilitation. Lisa's presentation went over the support she gets from her facilitator to do her advocacy work. She also talked about what it involves, and the roles and relationship between the member and facilitator.

- Communication between self-advocate and facilitator is very important
- Facilitators should take the lead of the selfadvocate when discussing what type of support the self-advocate needs most

- Self-advocates and facilitators should have written and signed facilitation agreements
- Self-advocates need to feel comfortable telling their facilitators when they don't want or need their help.
- Boundaries are very important
- It's a good idea to have a backup facilitator
- Committee members had a discussion about facilitation
- Facilitators must be patient
- The self-advocate must be comfortable in saying that something is not working for them, and facilitators can go a long way in making that safe for them to do so. This begins with not taking anything personally.
- Honest and open communication is always the key

Miguel Lugo gave a presentation on his life after sitting on DDS CAC. He also shared a short film made from a poem that he wrote about how he felt navigating the community, and how people passed judgment on him because of his disability.
