The concept behind this request is to bring Person Centered Thinking (PCT) to the forefront of services at the Carole Sund Center and in Humboldt County. Currently there is only one PCT trainer in the county causing most people to travel out of the county for this essential training. The funding would be used to develop and maintain two Certified PCT trainers in the agency, as well as the delivery of PCT training to 50 agency staff members, 24 clients, and community members. Providing this training to all employees and clients in our organization will create an increase in staff awareness and empower each client to actively participate in making choices and decisions in regards to their needs, interests, and desires. This will transform the agency culture by instilling person centered practices into the program providing improved life satisfaction for attendees. The PCT trainers will also provide training to community members to allow more people the benefit of understanding of how to support individuals and promote personal choice. The mentorship, training, and on-going maintenance will be obtained out of county so travel, per diem, and lodging was included in the funding request. Once certification is obtained, the training will be provided at least 12 times and up to 16 times through the grant cycle ending June of 2021. Included in this request for funding is a \$300 stipend for each Carole Sund Center client that attends and participates in the PCT training. Providing stipends is imperative to compensate individuals for the time spent in training.
