Have you or the organization you work with been a past recipient of HCBS Funding?	With the first two HCBS grants the Arc hired and trained five Choice and Integration Specialists (CIS) and consulted with a national expert on the CMS Rule. The expert provided ongoing HCBS training and consultation and assisted in the development of the interest discovery tool. The CISs developed a Community Activity database and an Interest database to support and facilitate the grouping of individuals with like interests. By the end of the grant cycle all 541 individuals will have participated in the interest discovery process followed by the development of their Choice Based ISPs. The CIS have provided 3 of the 5 required sessions with local ethnic-focused community groups to increase awareness of HCBS. Two key staff will be certified as trainers in Person Centered Thinking by the end of the current grant cycle. At time of writing, 62% of AC, ADC, and WAC program individuals have completed an Interest Assessment and their interests are stated on their Choice Based ISPs. Over 250 Direct Support Professionals received training on the CMS HCBS Rules, The Discovery Process, Making a Meaningful Day, and how to complete Interest Assessments.
Please provide a brief description of the service/ setting that includes what a typical day consists of and how services are currently provided; include barriers to compliance with the HCBS rules.	The AC, ADC and WAC program individuals participate in on-site services and do not have the same option to be in the community as much as they would like to be due to staffing ratios, mobility and health limitations. Many individuals now have Choice Based ISP goals geared toward activities based on their individual interests and have participated in several community outings. Currently about 2% of their time is spent in the community.

Identify which HCBS federal requirements this concept addresses that are currently out of compliance.

Currently, the Arc's Activity Centers, Adult Development Centers and Work Activity Centers are not achieving full compliance with Federal Requirement #1 because: existing staff ratios don't support the identification and integration with individually-defined communities; program staff need more training and guidance on how to incorporate integration with chosen communities in daily service.

The Arc of San Diego seeks funding to support identified individual choices and increased exposure to communities of choice. HCBS knowledge gained in previous HCBS grant cycles will be continued and reinforced with Direct Support Professionals, individuals served and their support teams.

Facilitation and Implementation of Community Inclusion

- A. Under the guidance of the Sr. Director the Choice and Integration Specialists (CIS) will facilitate & mentor individual choice and community inclusion through engaged activities outside of Arc facilities utilizing the Community Activity & Individual Interest Databases. This support is required in order to integrate due to the communication, mobility and behavior barriers presented by supported individuals.
- B. CIS will facilitate community inclusion and individual choice in services at Arc locations by mentoring and observing Direct Support Professionals and Case Management staff.
- C. The Sr. Director will guarantee a successful transition and ongoing training to ensure sustainability of HCBS concepts accomplished in previous grants by:
 - Providing ongoing training and support to CIS staff as they successfully transition the Interest Based ISP development to Case Management
 - Supervising the CIS in training Direct Support Professionals on: Making a Meaningful Day; Community Activity Database; Participant Interest Data Base and Choice Based ISP
