The California Early Start State Systemic Improvement Plan (SSIP)

The SSIP is a federally required multi-year plan states must develop to improve results for infants and toddlers with disabilities. States must identify a measurable child result as the focus of their SSIP and report annually to the federal government on its progress in the measurable result through 2020.

Based upon input from Early Start stakeholders, California selected to focus on increasing the percentage of infants and toddlers with disabilities in California who substantially increase their rate of growth in positive social-emotional skills by the time they exit the early intervention program. Three different improvement strategies were identified to accomplish this task:

- Parent and provider education;
- Professional development; and,
- Interagency collaboration.

The Local Implementation Assessment (LIA)

The LIA template has been created to assist regional centers and their local implementation team members with planning and documenting how they will implement the SSIP at their local level.

Intended Goal

The LIA's intended goal is to help the regional center and local implementation team understand minimal implementation requirements and recommend additional implementation activities that the local team may want to consider.

Stakeholders and Partnerships in Early Start Services

Local implementation teams are not limited to the activities associated with this template and are encouraged to utilize their existing resources and partnerships to implement the SSIP. It is recommended that local implementation team members participate in developing the LIA or that the plan be shared with local implementation team members to ensure that a systemic approach is used in implementing the plan.

- 1. What processes and tools are currently used by regional center and provider personnel to evaluate and assess the social/emotional development of infants and toddlers referred to Early Start? Evaluation and assessment begins in the intake process with parent interview and observation of the child, and includes MCHAT-R for all children 18 months and older. Formal assessment tools used by vendor service providers and by community partners include Bayley-III, DAY-C, ABAS, ADOS, ASQ and ASQ-SE, Mullen, Hawaii/HELP and Batelle 2nd ed. In addition, family assessment/CPR (concerns/priorities/resources) is completed with the family at intake and annual review.
- 2. Please briefly describe how your regional center currently supports children and families in the provision of services that promote social/emotional development. As part of initial and annual IFSP, Take a Minute tools are reviewed with the parent and team and noted on the IFSP form. Supportive services are provided on an individual basis and may include behavioral services, credentialed special education in-home teachers, referral to Early Start FRC, Early Head Start, First 5 playgroups/inclusion specialist, and community mental health providers. In addition, RCRC participates in the Humboldt County 0 8 Mental Health Collaborative, which has sponsored an annual Children's Mental Health Summit, and provides the content/structure for IFECMH endorsement for community providers. IFSP outcomes focus on functional and family goals, integrating SE concepts into all program areas. First 5 Mendocino provides frequent trainings for Positive Parenting Program, and Lake County provides training in Nurturing Parenting. Early Start families can be referred to either of these agencies for these trainings. In Humboldt, First 5 utilizes the Strengthening Families: Protective Factors Framework for their FRC's and playgroups.

SECTION II: LOCAL SSIP IMPLEMENTATION TEAM

Please describe how the regional center will recruit local partner agencies and organizations to become part of the regional center's local implementation team. RCRC reached out to our community partners by email and personal contact, utilizing our existing collaborations, to invite participants to the SSIP orientation meeting. RCRC will continue to provide updates and resources re: SSIP and social emotional development at our monthly Early Start collaborative meetings, annual Humboldt/Del Norte Early Start retreat, as well as our community participation in other endeavors such as Humboldt County 0 – 8 Mental Health Collaborative. In addition, vendors will receive Take a Minute materials and SSIP information by email and as part of the referral and IFSP process, and as part of their initial orientation to Early Start when becoming vendored. SSIP and Take a Minute materials will be folded in to our existing outreach process, which includes periodic contact with medical providers, cultural supports such as Paso a Paso, tribal entities, and other community agencies.
