# The California Early Start State Systemic Improvement Plan (SSIP)

The SSIP is a federally required multi-year plan states must develop to improve results for infants and toddlers with disabilities. States must identify a measurable child result as the focus of their SSIP and report annually to the federal government on its progress in the measurable result through 2020.

Based upon input from Early Start stakeholders, California selected to focus on increasing the percentage of infants and toddlers with disabilities in California who substantially increase their rate of growth in positive social-emotional skills by the time they exit the early intervention program. Three different improvement strategies were identified to accomplish this task:

- Parent and provider education;
- Professional development; and,
- Interagency collaboration.

### The Local Implementation Assessment (LIA)

The LIA template has been created to assist regional centers and their local implementation team members with planning and documenting how they will implement the SSIP at their local level.

### **Intended Goal**

The LIA's intended goal is to help the regional center and local implementation team understand minimal implementation requirements and recommend additional implementation activities that the local team may want to consider.

### Stakeholders and Partnerships in Early Start Services

Local implementation teams are not limited to the activities associated with this template and are encouraged to utilize their existing resources and partnerships to implement the SSIP. It is

recommended that local implementation team members participate in developing the LIA or that the plan be shared with local implementation team members to ensure that a systemic approach is used in implementing the plan.

- 1. What processes and tools are currently used by regional center and provider personnel to evaluate and assess the social/emotional development of infants and toddlers referred to Early Start?
  - \*Any pertinent information listed on the referral form and any additional documentation or reports that are sent by the referring party.
  - \*Family assessment form that is filled out and returned at the time of intake.
  - \*Intake team completes the BDI 2 and the ASQ-SE at the time of initial intake: MCHAT is also completed for some children.
  - \*BDI 2 is administered at the initial intake and every 6 months by vendors and LEA programs to gauge progress.
  - \*In addition to administering a standardized test, intake teams and providers are encouraged to document clinical observations, parental concerns and child's progress noticed by family with a focus on child/family's strengths.

- \*Concerns and priorities are discussed/reviewed every 6 months.
- \*BDI 2 scores are used to complete the ESR at entry and exit from the Early Start program for the social-emotional domain and all other domains that are tested.
- 2. Please briefly describe how your regional center currently supports children and families in the provision of services that promote social/emotional development.
  - \*El's receive training in all areas of development and incorporate their knowledge and expertise into their visits with families. In addition, the intervention team is encouraged to take into consideration the parent-child interaction while addressing developmental needs.
  - \*Families are encouraged to pursue generic resources in the community such as play groups or story time at the library to promote social interaction in a natural environment.
  - \*LEA provides group opportunities in addition to weekly home visits in the natural environment.
  - \* Providers are expected to work as a collaborative team to support the parent-child relationship.
  - \*Early Head Start has a monthly socialization group.
  - \* In Santa Clara County the Early Start Program collaborates with other community agencies that provide mental health services to address behavioral and relational issues.
  - \* As a generic resource in Santa Clara county families who qualify for medical have access to the county developmental assessment team through KidConnections.

3. Training
Online training on social-emotional development is available to teams and the Early Start community. The online community of practice, made available by DDS and WestEd, will support the dissemination of information and resources and promote active discussion around implementation of evidence-based practices.

- 1. San Andreas Regional Center will develop a protocol to have all programs, providers, and service coordinators take the on-line training utilizing the early Start Neighborhood website. Eg: Strengthening Families (five protective factors).
- 2. Ongoing trainings will occur at meetings that include local Private Infant Programs and Early Start Service Coordinators. A 'topic of the month' will be established and supported by an expert presenter, or literature will be forwarded with the request for reflection upon the material presented. This will allow participants to gain a deeper understanding of the importance of Social-emotional development.
- 3. Intake agencies will be trained in Touchpoints.
- 4. A. Phase 1 of the SSIP will be on 10/24/17: Focus will be on introductory topics of Reflective Practice and Social-emotional outcomes focused on routine based practice, through the lens of a coaching model. It is requested that training facilitators incorporate cultural considerations into their talks. Resources from Cohort 1 and Early Start neighborhood will be introduced. Presenters invited: Jessica Dailey-Keithline (DDS) and Sheila Self (CDE).
- B. Phase II of the SSIP- Date TBD: Consideration will be given to a formal training around the topic of Cultural Sensitivity, in addition to training in Reflective Practice (Dr. Mary Claire Heffron depending on availability).
- C. Phase III of the SSIP -2/23/18: Training by Stacey Landberg. Topics will focus on how to write routine based goals in the social-emotional domain and all other developmental domains. Intervention will put emphasis on coaching and parent education.

How and how often will the regional center and its local implementation team members meet to share information on the progress of its implementation?

At least every three months (Quarterly). The key partners will meet in person to discuss the SSIP plan. It is hoped that the focus on "coaching" and the use of reflective practice will enhance the integration of training material and be a source of information gathering for future training and support.

How will the regional center and its local implementation team provide outreach to vendors, allied health professionals, parents and other members of the Early Start community in their local areas to inform them of the online Community of Practice and other SSIP resources? Basic data in the social/emotional domain can be secured through the Early Start Report. The San Andreas Team is discussing on reporting on one domain of the BDI-II at entrance and at exit Eg: Adult Interaction Domain. Anecdotal and observation can be gathered through each organizations doing a self-survey and report of their progress and process. San Andreas Regional Center may research on pre and post-test for families to measure social-emotional relationships. The latter has continued to be a challenge.
