TABLE 2B: FAIRVIEW DEVELOPMENTAL CENTER

In Fiscal Year 2018-19 through April 2019, 49 consumers have transitioned from Fairview Developmental Center (FDC) to the community.

In April 2019, 13 consumers from FDC transitioned to the community. In the previous month, Regional Centers (RCs) had projected that 17 consumers from FDC would transition to the community in April 2019. The projected placements that did not occur this month were due the need for extra time in the case of three individuals, and the delay of a home being ready in the final instance.
