In Fiscal Year 2018-19 through June 2019, 58 consumers have transitioned from Fairview Developmental Center (FDC) to the community.

In June 2019, 3 consumers from FDC transitioned to the community. In the previous month, Regional Centers (RCs) had projected that 6 consumers from FDC would transition to the community in June 2019. The projected placements that did not occur this month were due to provider issues in two cases, and the delay of a home being ready in the third instance.
