In Fiscal Year 2018-19 through May 2019, 55 consumers have transitioned from Fairview Developmental Center (FDC) to the community.

In May 2019, 6 consumers from FDC transitioned to the community. In the previous month, Regional Centers (RCs) had projected that 9 consumers from FDC would transition to the community in May 2019. The projected placements that did not occur this month were due to consumers needing a longer transition process in two cases, and the delay of a home being ready in the final instance.
