All behavior-analytic services provided are termed "idiographic", which means that they are individualized to the person served. Each client and each team that Dr. Morgan collaborates with considers person-centered variables that impact one's overall adjustment. Feedback obtained from each client since 2015 have been incorporated into the current proposal.
Does the concept address unmet service needs or service disparities? If so, how?	Yes. The proposed concept seeks to provide individuals and the teams that serve them with person-centered tools to compliment the robust behavioral programs that are currently in place.
Barriers to compliance with the HCBS rules and/or project implementation	#2: The individuals served do not currently have person-centered service plans. While individualized behavioral supports are identified and implemented, these could more heavily reflect person-centered preferences in interdisciplinary assessment reports – thereby leading to greater person-centered outcomes to compliment progress already being made towards IPP objectives. #3: While staff communicate professionally, the lack of training and support in the area of person-centered planning and communicating in clients' needed and/or preferred methods requires further development.
Narrative/description of the project. Identify which HCBS federal requirements are currently out of compliance; include justification for funding request	Heidi Morgan, Ph.D., BCBA-D provides robust interdisciplinary assessment consultant services to individuals in the San Andreas Regional Center. Dr. Morgan is a source of training and support to many teams throughout the catchment area and has the opportunity to positively impact progress towards IPP goals and person-centered goals.

Although Dr. Morgan herself has successfully completed Person-Centered Thinking training through Parents Helping Parents, the barriers to compliance could be addressed more fully with the following:

- Completion of the requirements to become a certified Person-Centered Thinking Trainer through The Learning Community (learningcommunity.us). Based on the Learning Community Website, this will require 114 hours of time plus out-of-county travel and related expenses.
- Completion of US Citizen-Centered Leadership Community of Practice, a 22.5-hour, 15-week online course to collaborate with other professionals in supporting the ideals of citizenship with and on behalf of people with disabilities who are vulnerable to social exclusion (see cclds.org).
- There are various certifications available to providers throughout the State of California. One "entry level" certification is called RBT, which stands for Registered Behavior Technician. This course requires 40 hours of training and additional skill assessments. RBT status is required in Enhanced Behavioral Support Homes in California, vet many of the RBT courses are incompatible with federal HCBS requirements. Many of the procedures discussed in the research are clinically sound but require further refinement to be fully HCBS compliant. Dr. Morgan and her colleagues are eligible to develop and implement an RBT training course throughout the State of California to bridge the gap between applied behavior analytic literature and HCBS requirements. This would include both in-person assessment time and the development of online educational technologies to support the development of person-centered **RBT** resources by 2019.
- Visual tools and aids to provide training to individuals and their providers on person-centered thinking and individual topics. This will enable Dr. Morgan to pair current verbal support with visual aids. This will accommodate individuals served and also increase the effectiveness of client-specific staff training conducted with teams.
