Person-Centered Practices/Planning Training Sessions Offered Statewide

The Department of Developmental Services (Department) is pleased to announce the launch of statewide training opportunities focused on person -centered practices and person-centered plan facilitation. The Department has contracted with Support Development Associates (SDA) to develop and provide these training sessions. Knowledge of the principles of person-centered practices and the ability to apply such principles is important for the successful implementation of the Self-Determination Program and meeting the HCBS settings requirements outlined in the January 2014 federal regulations. The intended audience for these training sessions is regional center staff, service providers, individuals who receive regional center services and their family members, and other interested stakeholders. Question of the Day

Q. If I live on my own does my Service Coordinator need to visit me every three months?

A. Yes, the rules from the federal government about SDP in California state "For consumers who do not live with their families, quarterly face-to-face monitoring is required to monitor the consumer's health, safety and well-being, assess the effectiveness of services, and monitor progress in meeting the identified goals." Basically this means your Service Coordinator is required to visit you every three months to make sure you are doing well and that your services and supports are working out for you as you planned.
