## Home and Community-Based Services (HCBS) Rules CONCEPT PROPOSAL

Existing regional center vendors may receive funding to make changes to service settings and/or programs to help them come into compliance with the HCBS rules. To be considered for funding, vendors must complete and submit this form and the Provider Compliance Evaluation form by October 1, 2016, to the regional center with which it has primary vendorization.

This form may not exceed three pages and must be kept in Arial 12-point font. The narrative should link to the federal requirement that is not being met. The Provider Compliance Evaluation should guide the narrative. The results of the Evaluation should be clearly laid out in the narrative. Additionally, the narrative should describe how the funding would achieve compliance. Concept proposals should be developed with a person-centered approach, with proposed changes/activities focused on the needs and preferences of those who receive services. The estimated budget and timeline need not be detailed at this point but must include all major costs and benchmarks.

Currently the schedule of activities participated in by clients at Social Vocational Services are developed by the staff person with the input of a group of clients and then set for the week with alteration only as needed. The client does not get to choose their staff person or the

	individuals in their group and the scheduling of activities is not predominantly focused on an individual as it is group oriented and intended to serve individuals in a cooperated group setting.

Identify which HCBS federal requirements are currently out of compliance; include justification for funding request	SVS will develop a new position and hire two Person Centered Planning Coordinators. The position will be specifically trained in Person Centered Planning requirements and the intent of the HCBS federal requirements. This person will work with the four SVS program offices served by RCEB to ensure compliance with the HCBS federal requirements. This Person Centered Planning Coordinator will train Case Managers and DSP staff in true person centered planning, match incoming clients to hired staff and clients already being served who share the same interests. This position will assist in the semi and annual meetings of the client to maintain a client driven process during the meeting. It will also include quality control of all plans for the individuals served by SVS; ensuring the goals of the IPP are being addressed in the program's INSP and are chosen by the individual as desired goals. The Person Center Planning Coordinator will provide the individual necessary information and support so that they may maximize their ability to choose and advocate to their maximum extent; identifying the individual's strength, preferences, clinical needs, support needs, desired goals and outcomes.

Family member have expressed concern over safety for their loved one to go into the community. Person centered training could also teach staff how to elicit communication of choice from individuals that are non-verbal. Individuals with communication challenges could be helped to communicate by using technology in the form of Laptops with software and/or lpads with applications.
