In Fiscal Year 2019-20 through October 2019, 21 consumers have transitioned from Fairview Developmental Center (FDC) to the community.

In October 2019, 8 consumers from FDC transitioned to the community. In the previous month, Regional Centers (RCs) had projected that 15 consumers from FDC would transition to the community in October 2019. The projected placements that did not occur this month were due to consumer health-related issues in two cases, and the delay of homes being ready for 6 other individuals.
