Opening

Dr. Marie Kanne Poulsen called the meeting to order at 9:02 a.m.

Introductions and roll call were conducted.

The Council reviewed the Agenda, which was approved without amendments.

Committee Reports

Improving State Systems

- **Foster Care Subgroup**

The Subgroup discussed the creation of a one-page infographic for the social work and juvenile justice systems to describe Early Start. The Subgroup plans to check with Los Angeles County for suggestions. The Department of Social Services (DSS) is partnering with the Department of Education (CDE) on a professional development symposium for analyst positions.

- **Insurance Subgroup**

The Process for Getting Early Intervention Services Survey is available in both [English](#) and [Spanish](#). The Council was asked to provide additional suggestions for dissemination.

The Subgroup is exploring data related to regional center compliance. Data sources may include regional center complaints, Department of Developmental Services (DDS) monitoring reports, anecdotal feedback from the field, Office of Special Education Programs (OSEP) reports, and CDE monitoring reports.

- **Family Navigation of Systems Subgroup**

The Subgroup is creating a navigation referral and resource tool for doctors. The Subgroup will have something to present at the October Council meeting. The Communications Committee will assist with a dissemination plan.

Communication and Outreach

The Committee is creating a file share system to archive documents. The Committee will gather data on the distribution function to track the reach of documents.

The Committee will be developing a communications plan for 2018-2019. Additionally, the Committee plans to work on an Interagency Coordinating Council logo.

Public Input

Public input was received at 9:45 a.m. It was shared that prenatal exposure is not being referred as high risk to regional centers and family resource centers (FRC). The Council discussed how to ensure that children are getting services that they are eligible for.

The California Speech-Language-Hearing Association provided an update on current efforts to update regulations to allow clinical fellows and speech-language pathology assistants to practice in California.

Voices from the Field

Statewide Screening Taskforce

The Statewide Screening Taskforce is a collaboration between DDS and the California Department of Public Health (CDPH) designed to identify opportunities to increase statewide screening and referral rates among health care providers. The work includes developing a toolkit focused on primary care along with recommendations for increasing screening rates in primary care settings. The [California Healthcare Provider Developmental Screening Toolkit](#) website is in place. Additionally, the Taskforce created referral cards for healthcare providers and developed [eligibility criteria](#) to ensure proper referral.

Infant Development Association of California (IDA)

The IDA is presenting a training, [Prenatal & Birth Psychology: Nurturing Human Potential from the Beginning of Life](#) on August 17.

On January 29, the Southern California IDA chapter will host the Early Start Policy Update 2019 in Los Angeles.

First 5 Association

[AB 11](#), requiring developmental screening services for children zero to three years of age, continues to move through the legislative process. The bill is currently in the Assembly Appropriations Committee.

Family Resource Center Network of California (FRCNCA)

FRCNCA represents the 47 FRCs with a Steering Committee member from each of the nine regions that meet monthly.

Through the Early Start Plus program, FRC staff attended a webinar, *Steps to Inclusion at Transition*.

FRCNCA representatives participate in the California Autism Professional Training and Information Network (CAPTAIN), which identifies and develops a cadre of staff with enhanced knowledge about autism and evidence-based practices across California.

Department Reports

Department of Developmental Services

DDS submitted the Annual Performance Report (APR). Based on the APR, OSEP makes a performance determination for Early Start. For the current APR, DDS received a "Needs Assistance" determination, which is an improvement from the last determination. DDS continues to work on data collection and monitoring. The [APR and the Determination Letter](#) are available on the DDS website. [Regional Center performance reports](#) are posted as well. The Annual Part C Grant Application has been submitted and received conditional approval based on necessary regulation updates to bring California into compliance. California received approximately \$55 million, which is about the same as last year.

Department of Education, Special Education

[AB 2704](#) would establish new Family Empowerment Centers. The bill was held in committee and will not continue through the legislative process this year.

Funding is available to address inclusive preschools. Through a competitive grant process, funding will be available for facility updates or additions, adaptive equipment and professional development. The program will roll out over five years and if successful, it may continue.

The Division of Early Childhood is developing a monograph on teaming, collaboration and leadership that will be released in the fall.

CDE continues to develop least restrictive environment exemplar sites. These sites will specifically support children with disabilities through fidelity, coaching and training for teachers and coaches.

Ten million in one-time funding is available for the county offices of education for preschool inclusion.

Online training modules for the Desired Results Developmental Profile will be accessible to teachers to assist with tracking and collecting data and providing feedback to the Special Education Local Plan Areas and Local Education Agencies.

Department of Social Services – Child Care

There will be an expansion of home visiting that targets the CalWORKS caseload. This is an opt-in program in which counties will need to apply.

DSS has convened a task force to develop recommendations to reduce child poverty rates. The recommendations will be released in October.

Department of Social Services – Foster Care

Additional positions are being added to the division that focus specifically on children zero to five. The Division would also like to reconnect with the Council on strategies to ensure that children in foster care are assessed and receive services.

Office of Head Start

Head Start is seeing major quality improvements from a long-term project on expulsion.

Department of Managed Health Care (DMHC)

The [2017 annual report](#) and [infographic](#) are now available online. Both of these documents highlight DMHC's activities during 2017 and include key statistics about the Department.

The Department of Health Care Services released [geographic access](#) for different provider types. The standards calculate the appropriate distance and travel time requirements.

Department of Public Health

The Maternal, Child and Adolescent Health Division is engaged in the strategic planning process. Currently, needs and gaps are being assessed, partners are being identified and engaged, and key priorities are being identified. The next meeting is in August and will continue quarterly.

The Council meeting adjourned at 12:15 p.m.
