Although we are transforming and working on the HCBS person-centered implementation, we have limited resources for meeting each individual request. As we have many medical appointments, the vehicles are often in use as medical appointments serve as a first priority. For each individual to receive individual services in the community, public transportation is not always a timely or efficient for time management, nor can individuals that we serve handle the patience of waiting for buses due to their behaviors. In addition, there are limited public transportation resources due to over concentration for the population in this area for such public rides.

All individuals participate in community outings, they are not always "individualized" as we have limited resources for transportation. We would require additional vehicles to be able to meet individualized objectives so staff could assist them with their transportation.

Staff require HCBS Person-centered training to be able to support and assist to learn how to implement the individual plans. Training would teach them to identify the needs of each individual choice and learn how to provide proper transportation needs. This would also assist the home to learn to identify person-centered focus To and For the individual for transportation needs.

Individuals who wish to seek paid employment would need to be identified. we would need to train the staff and also implement this goal and objective into their

plan to support their desires. Staff would need to be included in the plans and trained to be available resources and guidance for implementation.

In order for the individuals to have the option to control their personal resources, we will require the initial staff training for Person-Centered training, but not limited to ongoing training. There should also be training for "Train the trainer" training in order to learn what is required for HCBS rulings and how to support staff implementation. This training would provide us the ability to be able to write, apply, and implement Person Centered Plans.

Seabright currently provides private rooms for each individual and none of the bedrooms are currently shared by anyone, as we are licensed for 8 and there are 8 bedrooms in total. Most bedrooms offer a half bath and each individual has a key to lock their bedroom door.

Each individual in the home and the community integration plan is encouraged to express their individual desires and preferences for daily activities. They have the ability to choose and perform their individual preferences for both in the home and in the community that meet their needs. Public transportation is not always a timely or efficient for time management, nor can individuals that we serve handle the patience of waiting for buses due to their behaviors. In addition to over concentration for the population in this area for such public rides, we are limited with resources. As we strive to supply the resources for each individual, we have limited vehicles for transportation. We lack the number of activities due to lack of available vehicles on hand. We do have the appropriate number of staff and due to liability, we choose not to have employees use personal vehicles for these situations. We would require more vehicles to meet these person-centered requirements as we serve up to 8 individuals.

The Seabright Community Integration plan could benefit the individuals with an upgraded activities room. Currently in use, they could benefit with the use of some modern computers or lpads with stands to assist with online learning resources and job access. This would provide them the ability to seek and apply for jobs, activities, and obtain community resource access for education and job resources. They would also benefit with ergonomic office chairs and tables that are designed for ergonomic safety and comfort while accessing available community job and educational resources.

Autonomy is communicated and trained to staff throughout the individual's journey as we promote independence. As we maneuver through implementing the HCBS regulations, we require some assistance to provide additional daily activity supports To and For each individuals choice.

Individuals in the home are able to express their staff support. If they desire another staff vs. a staff that is supporting them, they can choose to have an alternate staff assist them that is on shift.

Individuals have the opportunities to access outside resources and are discussed in their individual conversations with their families, support teams, and advocates. These decisions do not need wait or be discussed in routine meetings but anytime they deem changes are required for their life choices. Each individual deems the time and decision of who they desire for their care and support system.

Every individual has an admission agreement in place for Title 17 and Title 22 Regulations. Although there are agreements and HCBS regulations, these documents have the ability to be changed anytime as individuals are allowed to change their minds for residential decisions. They have the capability to express their living situation anytime and are encouraged to contact their service coordinators to discuss their desires. In addition to conversations about their residential opportunities during routine conversations, they are provided with the telephone numbers of their service coordinators. These conversations also take place during their reviews and meetings. Person-centered planning and focus on their desires are always encouraged and they are informed of other residential resources and choices.

We encourage healthy choices such as fruits and vegetables however, we also have a variety of snacks and food available for them at all times in addition to the mandated posted menu. Each individual is encouraged to participate in the planned menu's so that we meet the food needs To and For each individual. We encourage them to plan the meals provided on the weekly required posted menu. Some of them enjoy assisting with preparing their own meals. We encourage them to not only be involved with their meal planning, but learn to demonstrate their independence by learning to prepare and cook meals where desired.

Each individual has freedom and support to have their own schedule and express their desires with how they want to spend their time, in addition to choosing which activities they want to perform and when. We are currently practicing the To and For models of HCBS and implementing their individual choices.

All individuals have full access to the kitchen, dining area, laundry facilities. We have a few tables and chairs outside with umbrellas where they can choose to relax under the shade.

We have set main meal times in order to prepare main meals however in order to meet HCBS regulations and provide the freedom for each individual to be able to prepare their own meal at any given time, we would require an updated kitchen area. As this is a challenging area for those with disabilities, we would need to remodel a kitchen suitable to meet the needs To and For each individual accessibility. They would require adaptive equipment in order to be able to function and prepare their own meals. Adaptive equipment needs would be cabinets they could reach without step stools for safety, an open floor plan for non-ambulatory access, touch faucets for water access, wheel chair counter access, adequate light switches reachable and accessible, electric stove top instead of open gas flame, accessible low installed microwave oven, large knobs on cabinets easy to grab, easy roll out shelves in oven, refrigerator with accessible ice and water, dishwasher that has easy operational buttons for ease of operation.

Food preparation and kitchen clean-up is a crucial independent life skill that should be acquired however, many individuals lack those skills and rely and depend on staff to prepare their meals. Safety training would need to be provided to teach individuals the use of gloves for cross contamination for meal preparation, the use of potholders for hot surfaces in addition to understanding that meal preparation is key for learning as it is important for daily survival.

It is not easily accessible for many individuals to be able to gain access to the space and have the accommodations met to meet the needs for person-centered kitchen activities. The current kitchen is very outdated and we would need an open peninsula for food preparation and cooking safety training. The current kitchen is not safe for individuals to use especially with a gas cooktop with open flame. The current kitchen

lacks the convenience of modern appliances to serve and train the individual for person-centered food planning goals to promote independent access. The kitchen is too small, closed off, and unsafe to have multiple individuals in the home around the same time of day in that area to be able to learn how to plan, prepare, and cook their own meals.

We promote the individuals to be able to have visitors outside the home as they choose. Although we provide holiday meals and celebrations, they have the right to depart the home when they choose and to stay with others on holidays, weekends, and times when they want to visit others. They are never expected to remain the home except for when they choose to.

We have a nice patio outside with tables, chairs, and umbrellas. The inside of the home provides their own individual private bedroom and some have a shared half bath in between their bedrooms in addition to full bathrooms available. There is a total of seven bathooms, which none of them meet the safety requirements of HCBS standards. The bathrooms were built in the 1940's and are in dire need of updating to comply with safety requirements such as grab bars and a non-slippery shower floor.

The furniture is accessible to each individual however the appliances are not user friendly in the kitchen as they have a manual dishwasher that operates in a manual setting only as if you overfill the dishwasher with water it will overflow all over the floor. Individuals in the home would require a regular dishwasher where you push one button to operate that is easy for them to learn. The kitchen is very old as it was built in the 40's and requires updating in order for the individuals to be able to operate the appliances as they are complex to use. The stove is gas and unsafe for individuals as there is fire on the stove top instead of electric that would be safer for the individuals in the home to operate. As safety is a concern, the individuals would require an updated kitchen in order to be able to complete their individual meal preparation.

Appliances such as Air Conditioning are not available in the home. Santa Cruz does have some very hot months and it would be more comfortable for the individuals to reside in a home that is climate controlled. These boundaries of temperatures are not only HCBS but also mandated that the home not be more than 85 degrees. There are times in the summer that the temperatures were excessive and extremely uncomfortable.

PG&E has the ability and control to shut-off electricity. Due to the severity of the individuals in the home, we would recommend a generator plumbed into the home that can be turned on during the PG&E emergency shut-down times. We have fragile individuals in the home that rely on C-Pap sleep machines. This is a detriment and can be dangerous when they are unable to use their C-Pap machines while sleeping.

A television in the education room would be beneficial for individuals to watch and learn educational segments and use for staff training.

A number of individuals that resided at Darwin House for several years received devastating news their home was closing. With much hard work, we were licensed and vendored for the new Seabright Villa 9/19. This is a specialized home that not only provides residential care for up to 8 individuals; but also has a Community Integration Day Program for severe intellectually challenged, severe mental deficits, and extreme behavioral conditions. Although we are proud for the continuation of the home, there is much work to do for the HCBS implementation. A typical day offers services provided offer a full array of activities provided, such as field trips to museums, shopping, amusement parks, malls, and many other places. We also focus on educational learning and stimulation to focus on goals and objectives, while reducing behaviors.

2. Please provide a brief summary narrative of the concept for which you are requesting funding, including justification for the funding.

While we strive to provide excellent care and services, the new HCBS Federal Ruling has prompted us to evaluate our current services with our residential and community integration programs. As we have identified the new mandated regulations, we have identified that some of the changes require funding that is not available to us. These mandated changes prompt us to comply however, we require financial assistance in order to implement and comply with the new regulations.

The proposed outcomes come first with rolling the training and objectives out to the staff that care for the individuals. They need to understand and be able to implement the key components that will carry through the home. The methods used will be tracked quarterly in the HCBS quarterly reports to show how we were able to implement and sustain the HCBS goals and track the achievements. Individual quarterly meetings will track the goals and objectives to demonstrate how the improvements impacted their lives directly.

7. Please describe how and/or what was done to include input from the individuals served in developing this concept? Discuss not only the development of the concept, but also what steps were taken to identify the interests and desires of the individuals and who was involved in that process.

We discussed the opportunities that are available to them and had a meeting to discuss what desires they each had. We gave them examples and shared some of the concept ideas and expressed to them the opportunities that they should have. In sharing these ideas, they shared some of their dreams such as learning to cook and preparing their own meals. To be comfortable in the summer as some of them expressed it was hard to sleep on hot summer nights. We provided examples and asked what meant the most about how and where they wanted to spend their time.

8. Please describe how the concept you propose will enable you to provide more personcentered services to your clients.

.All concepts requested are to support those individuals to grow and prosper with full support in a person-centered approach. Having additional resources such as technology where the individuals may access jobs and be taught how to apply themselves for employment can satisfy their work objectives. Being able to train staff on the new regulations will assist us to remain in compliance and learn how to implement the individual's person-centered planning. Obtaining extra vehicles to be able to transport to their desired places will give them the ability to access the community more often and provide additional resources for a better quality of life. Having air conditioning during the summer months will provide each person a comfortable place to reside on the hot summer days. For those that use C-pap machines, a permanent generator would benefit their overall health. Ergonomic tables and chairs where they can be comfortable while using computers or I-pads to gain community access for jobs, entertainment, and education. Ukeru training for staff to assist the individuals with physical aggression to be safe from harm

9. Please address your plan for maintaining the benefits, value, and success of your project at the conclusion of 2019-20 HCBS Funding.

The annual plan is to become HCBS compliant and to implement Person-centered training, focus, and implementation for the individuals that reside in the home to have more choices and be able to thrive in a less group type atmosphere. Maintaining an individualized planning goal in addition to allowing them to practice individual growth potential and freedom with job opportunities and accessible community availability.
