

REPORTED POSITIVE COVID-19 TESTS AND DEATHS OF REGIONAL CENTER CONSUMERS

DATA PROVIDED BY REGIONAL CENTERS AS OF 7/21/20

These tables compile data provided to DDS by California's 21 regional centers. Updates received from each regional center every business day include information for individuals known to them to have tested positive for COVID-19. Data is provisional and may change as regional centers provide updates. Details regarding gender, age group, diagnosis and self-reported ethnicity are retrieved from separate databases of information for all regional center consumers.
