

DATA PROVIDED BY REGIONAL CENTERS AS OF 6/27/20 (Week 26)

These tables and charts compile data provided to DDS by California's 21 regional centers. Updates received from each regional center every business day include information for individuals known to them to have tested positive for COVID-19. Data is provisional and may change as regional centers provide updates.

Data is displayed by week; weeks start on Sunday, and the first week of 2020 began 12/29/19. Governor Newson declared a State of Emergency related to COVID-19 on 3/4/20 (week 10); DDS started collecting surveillance data on 3/16/20 (week 12). The data labels below show the top five single-week new cases since week 12.









#### **Chronology for Safety Net Support Services**

July 1, 2020

October 2005 – SB 962 (Chapter 558, Statutes of 2005) homes: ARFPSHNs are developed for closure of Agnews DC and supported closure of Lanterman DC, Sonoma DC, Porterville DC (PDC) GTA and Fairview DC.

**June 2012** – Fairview STAR opened for individuals court-ordered to DDS for up to 13 months of treatment and support.

May 2013 – DC Task Force convened to examine the future of the state's developmental centers.

**January 2014** – DC Task Force report established new models of care (State-Operated Acute Crisis services, EBSH and CCH).

**July 2014** – DS Task Force convened to examine opportunities to strengthen the community-based services system.

**April 2015** – Sonoma STAR opened.

May 2016 – DS Task Force Safety Net Workgroup met.

July 2016 – DS Task Force Safety Net Workgroup met.

**September 2016** – DS Task Force Safety Net Workgroup met.

January/February 2017 – To inform the Safety Net Plan, DDS held three stakeholder workgroups (in Napa, Fresno and Costa Mesa) to discuss services for persons with significant behavioral and mental health needs, alternatives and transition options for persons with forensic needs, and safely transitioning individuals.

May 2017 – The Safety Net Plan for crisis and other safety net services was released to recommend services to support individuals with the most challenging service needs, using person-centered thinking and with a focus on cultural competence. The following services were developed:

- Additional STAR services (three homes in Northern California, two homes in Southern California)
- CAST services state-operated mobile crisis services (North and South, began January 2018)
- Three vendor-operated PDC STP step-down homes to prepare individuals for the transition to their home community
- STP Intensive Wrap Around to support individuals during their transition into the community
- Four vendor-operated IMD step-down homes
- IMD Intensive Individualized Transition Services (ACRC and SGPRC contracts)

**December 2017** – DDS staff begin scheduled on-going calls with RCs to plan services for individuals in IMDs and the DS Task Force Safety Net Workgroup met.

#### **Chronology for Safety Net Support Services**

July 1, 2020

**February 2018** – DS Task Force Safety Net Workgroup met twice.

**June 2018** – DS Task Force Safety Net Workgroup met.

**September 2018** – SB 175 (Chapter 884, Statutes of 2018) designated up to 10 beds for Desert STAR services until June 2021.

**Budget Act of 2019** – Authorized the following Safety Net Services:

- Central STAR serving adolescents (temporarily at PDC)
- Central CAST
- Two Central STAR homes in the community (permanent)
- CCH model expanded to children and adolescents Four CCHs for children and adolescents will be developed through ACRC, RCEB, VMRC, and SDRC. The FY 2019-20 budget included funding for the development of three of these facilities; the fourth was funded through the FY 2019-20 CRDP.
- Two CCH homes and two EBSHs for children with multi-system involvement in RCEB and SDRC to support AB 2083 (Chapter 85, Statutes of 2018) efforts, funded with FY 2019-20 CPP funds
- Staffing for DDS and RCs to implement AB 2083
- 1:25 caseload ratio for consumers with complex needs
- Specialized home monitoring RC staff monitor EBSHs, CCHs and ARFPHSNs on a monthly basis; DDS staff monitor every six months

**February 2019** – DS Task Force Safety Net Workgroup met.

August 2019 – DS Task Force Safety Net Workgroup met.

**November 2019** – To inform its updating of the Safety Net Plan, DDS held three stakeholder workgroups (in Napa, Fresno and Pomona).

**December 2019** – DS Task Force Safety Net Workgroup met.

March 2020 - DDS released directives related to COVID-19 that:

- Required regional centers to request and receive approval from DDS prior to moving a person into a licensed residential setting to limit the exposure to COVID-19.
- Limited admissions and discharges to/from Porterville Developmental Center, Canyon Springs Community Facility, or a STAR Home until determined safe.
- Requires regional centers to report when an individual is tested for COVID-19, is hospitalized due to COVID, or passes away due to COVID through the special incident reporting system daily.

#### **Chronology for Safety Net Support Services**

July 1, 2020

#### April 2020 – DDS continued to release directives related to COVID-19, including:

- Waiving certification requirements for administrators, direct care lead staff or direct care staff in EBSH and CCHs to be certified as Registered Behavior Technicians.
- Amending reporting requirements for regional centers to report if an individual has tested positive or died as a result of COVID-19.

#### June 2020 – DDS continued to release directives related to COVID-19:

- Issuing a directive rescinding previous requirement that regional centers request DDS approval for placements into licensed residential settings, as regional centers are expected to continue to monitor safe movement.
- START expansion (prioritized within existing CPP funding) authorized for the following regional centers: ACRC, RCEB, SCLARC, and WRC. Budget action deferred additional funding for START expansion to 2021-22.

#### **Budget Act of 2020** – Includes:

- Trailer bill language makes EBSHs permanent and increases by five (5) the number of EBSHs that can have DESP.
- Temporary increase of 20 individuals to the Porterville DC STP population limit from 211 to 231 individuals.
- Expands the diversion program for individuals with developmental disabilities.



#### Children and Youth in the Child Welfare System: AB 2083 Implementation

#### **BACKGROUND**

Intent of AB 2083 is to develop a coordinated, timely, and trauma-informed system-of-care approach for foster children and youth who have experienced severe trauma.

- Approximately 5,700 minor court dependents are regional center consumers.
  - Each county to develop and implement a memorandum of understanding (MOU) with local system partners.
  - Establishment of a JRT.
  - Development of a technical assistance process for partner agencies.
  - Recommendations to address identified gaps in placement and service options.
  - Collaboration on a multi-year plan to increase systems capacity.

#### DDS

DDS has been implementing the requirements of AB 2083, including:

- In response to COVID 19, providing technical assistance, system linkages and support to local coordination for dually served youth.
- Participating on the Children and Youth System of Care State Workgroup.
- Providing technical assistance and training to regional centers on MOU development.
- Participating in the interdepartmental Children and Youth System of Care Technical Assistance Team.
- Providing monthly statewide technical assistance webinars on the MOU provisions required per AB 2083 for all system partners.
- Established and implemented a technical assistance process with partner agencies per AB 2083.
- Participating in local interagency child specific technical assistance calls.
- Begun initial development work on the continuum of care gaps analysis per AB 2083.

#### **REGIONAL CENTERS**

- Developing their interagency leadership teams.
- Participating in MOU development with their local interagency leadership teams.
- Participating and supporting coordination of services.
- Participating in local interagency child specific technical assistance calls.

#### COMMUNITY DEVELOPMENT FOR CHILDREN WHO ARE DUALLY SERVED


RCEB and SDRC received approval and CRDF, to individually develop comprehensive residential services for children with complex needs and who have multi-agency involvement. Both RCs will develop one CCH and one EBSH for children who are dually served. A total of four homes will be developed, and will include:

- Comprehensive rate structures and enhanced case coordination
- Coordination to specialty mental health services and collaborating with nonpublic schools and local education agencies

**UPDATE:** Both RCEB and SDRC have awarded RFPs for the HDO and service provider.

The projects have a projected service date of Summer 2021. DDS holds regular calls with the RCs to track and monitor development and progress.







#### Community Supports and Safety Net Services Summary - December 2017

#### **General Definition of a Safety Net:**

Timely access to essential services and supports necessary for persons with developmental disabilities to maintain health and safety and to address medical, psychiatric, behavioral, residential, staffing, equipment, or other needs, when other services and supports fail, are interrupted, are not available, or additional services and supports are necessary for an urgent or medical need. May or may not require a change in placement.

#### **Definition of a Crisis:**

A situation that without the presence of services would result in a severe negative impact to that person's life

#### **General Principles:**

- A range of supports is necessary for a "safety net' system, if a piece is missing, it impacts the whole system
- The focus should be on person-centered planning
- Safety net involves many components- an enhanced medical system, including medical, dental, behavioral health, equipment repair, medication tracking, day program, and employment
- The safety net system should be flexible
- Services must be developed to support consumers who are involved or at risk of becoming involved with the criminal justice or civil commitment systems
- Trusted, trained staff are key
- Services should align with new federal rules
- Ensure services are available throughout the state
- For crisis services there must be immediacy
- Utilize least restrictive interventions
- Focus not only on the point when someone enters a crisis, but also the point before they enter into crisis
- The priority should be creating stability and keeping people in their homes
- There should be a place where people can be stabilized and then transitioned back when it's safe for the community and the person
- There should be mechanisms to help people return to their former home after a crisis if they want to return to that home

- Prevention is important to keep someone from escalating into the criminal justice system
- Look at the original, organic diagnosis, in addition to what is immediately presented for intervention techniques
- With consumers who have been traumatized or abused, look at compliance, prevention measures and behavior factors
- Ensure training in trauma informed care
- We need to develop an array of living options for those in an Institutions for Mental Disease (IMD) due to a crisis so they can return to the community
- There needs to be a reeducation of systems involved in crisis care, including stakeholders outside of the DD/IDD system, such as the police
- Self-determination should be examined as a component
- There should be a safety net that supports individuals of all ages, from youth to seniors
- There needs to be state oversight to ensure the delivery of quality services

#### **Three Areas of Focus and Policy Recommendations**

#### **Pre-Crisis Service Recommendations**

- There should be a model of funding similar to the Community Placement Plan (CPP) that allows for startup, support and innovation for those currently being served in the community.
- Staffing and training should be evaluated for specialized facilities and supports, as well as the needs of complex consumers
- There should be more robust "warp- around" services, such as medical, dental, psychiatric management, medication management, and durable medical equipment
- There should be a focus on person-centered planning and evaluation of supports
- Utilize state staff transferring into the community
- There should be a focus on cultural competencies and language barriers
- Improved transportation
- Increased therapeutic day program options
- Development of secure housing to prevent more restrictive placements

- There needs to be better communication across the system about crisis services and supported living
- The goal should be to keep people in their homes

#### **Crisis Services Gaps**

- There should be faster placement and more flexible schedules for return back to the community
- There should be comprehensive assessments of people in crisis, which include thinking long term about the individual needs
- Ensure crisis programs correctly medicate
- Develop more mobile, timely crisis teams
- Increased crisis setting capacity, potentially state operated
- Develop resources for families to call if an individual is having a crisis
- Reduction in caseload for a period of time for individuals who are in crisis
- There should be training available for first responders for our consumers in crisis

#### Gaps in Fundamental Services

- Develop more managed care
- Need to have flexibility in timelines in movement
- Need to develop long-term, community based, residential options for individuals with significant service needs
- Need to develop community based models that support the service needs of individuals involved or are at risk of becoming involved in the criminal justice system
- Need to develop long-term community options for Registered Sex Offenders
- Try to prevent bouncing around from home to home; makes the individual look undesirable and providers do not want to take that individual safety concerns and psych issues
- Have complex crisis settings throughout the state so individuals are not traveling long distances during a crisis
- Ensure a "no reject" setting

- There needs to be more state oversight of safety net services
- There should be a transition rate for service provider staff to allow them to help individuals transition through multiple settings
- There should be start-up funds for the community to help develop safety net services, similar to CCP
- There should be more coordination with police and first responders
- There should be an examination of the median rate

#### Recommendations for the California Department of Developmental Services (DDS):

- The department should evaluate where there are service gaps in crisis and "wrap-around" services throughout the state
- The department should evaluate opportunities for increased training and coordination
- The department should evaluate its current oversight and work with stakeholders on refining and enhancing this oversight to ensure a quality statewide safety net
- DDS should incorporate these principles and recommendations in to their legislative report on safety net services
