Family Support Network will screen children, and make referrals to community partners. The referrals would include the Regional Center, LEA's, Optometrists, Dentists, Mental Health, and their Primary Care Physician. The developmental screenings assist families with receiving early intervention, and linking families with other resources within our community.

During the period of 7/1/2016-present, 15 developmental screenings were held in collaboration with our community partner Family Support Network; 513 children were screened, 407 referrals being made .Ethnic breakdown of the children screened: 52% self-identified as of Hispanic descent, 27%, of Asian descent, 1% self-identified as Middle Eastern descent, and 20% self-identified as other. This has been a very successful partnership and we would like to continue to provide ongoing support for our CBO partner to reach out to more diverse populations to help with early screening. Children and parents in diverse communities are able to access developmental screenings to address their concerns and receive parenting support and referrals as needed. * Success story: When working with Vietnamese-speaking families, the Cultural Specialist often heard from families that developmental	
	screenings helped to open the door to needed therapies for their child, especially first-time parents. Parents relied on their child's pediatrician and often did not receive appropriate referrals to either Regional Center or therapies when they expressed their developmental concerns with their doctor. Parents heard the pediatrician respond that "boy talks later," "everything is fine," "she will catch up in a few months," etc. The collaboration between RCOC and Family Support Network helped to screen more children, especially those in under-served neighborhoods, and provided appropriate referrals to the Early Start program or to special education preschool.

As of 06/30/2019, RCOC served 3762 Asian individuals in both Early Start and Lanterman Program (17.3% of total persons served). Comparing the current data with date from three years ago (RCOC had only served about 13% Asian population), we did make some progress in Child Find Activities. However, new census data will come out in 2020 which will undoubtedly change the demographics, and the goal of outreach within the Asian community is to ensure that families are aware and are able to access regional center services. We are hoping to match the percentage we serve with overall county population percentages. More specifically, the percentage we serve with the overall county population percentages. More specifically, the Vietnamese population is the third largest in Orange County, so much of the focus of our outreach efforts will be in that community. Costs for the Asian population (\$15,466/year) are closer to the overall average (\$18,610/year), but are still lower than for the White population.

Regional Center of Orange County collaborates with CBO (Family Support Network) to determine what pockets within Orange County have under-served and diverse population that would benefit from Developmental Screenings. For example, Westminster and Garden Grove, are two geographic areas within Orange County that have a majority of Asian population; therefore, we should host Developmental Screenings to target the Vietnamese and Korean communities.

Our experienced informed us that non-English speaking families are afraid to travel outside their neighborhood. Therefore, its important to have screenings in their neighborhoods. Families will be linked to additional resources and regional center services. Having access to Developmental Screenings can reduce barriers to services for individuals with intellectual and developmental disabilities and their families, because families will be presented with information, about their child's development, and resources. For example, families knowledge will increase about regional center services and community partner services (LEA's, Support Groups, and other Community Based Organizations).

By providing developmental screenings in the neighborhoods of non-English speaking families (i.e:at local family resource center, community clinic, etc.), more under-served families will be able to access RCOC services, diminishing the current disparity. RCOC will share flyer of the planned Developmental Screenings with organizations that serve individuals with intellectual and developmental disabilities and their families.
