**RECOMMENDATIONS**

During the monitoring review, the Department of Developmental Services (DDS) reviewed multiple records where:

- services did not begin as soon as possible after consent was obtained; and
- transition conference did not occur in a timely manner

Considering what is outlined above, DDS recommends RCEB to align practices/procedures related to:

- timely provision of services; and,
- transition conference requirements

as required by 34 Code of Federal Regulations (CFR), §§303.344(f)(1) and 303.209(c)(1)
