### Advancing Cultural Humility through Effective Dialogue

In this keynote, presenters from The Dialogue Company (TDC) will support early intervention professionals to advance equity in everyday opportunities. This session will focus on using Candor, Compassion, and Courage to engage others in conversations that build bridges to greater inclusion. TDC focuses on designing and facilitating meetings, workshops, and other encounters that allow for the expression of divergent perspectives for the greater good. The company deeply believes that increased inclusion based on values builds connections that pay off in better decision-making, increased employee engagement, and greater workplace satisfaction.

### **1.A. Reflective Session for Supervisors**

Supervisors must take care of themselves so they can take care of their staff. Participants will discuss specific challenges they face as supervisors right now, as well as self-care strategies to address those challenges.

### **1.B.** Meeting the Needs of Children with Multiple Disabilities

### Presenters: Julie Maier and Myrna Medina, California Deaf Blind Services

Many children who receive Early Start services have multiple conditions that contribute to their eligibility. Learn strategies for ensuring that Individualized Family Service Plan (IFSP) planning for infants and toddlers with multiple disabilities includes comprehensive assessment, service planning, and service provision that addresses ALL of the child's identified needs.

### **1.C. Darby's Legacy: Resources for Families of Children Who Are Medically Fragile** *Presenters: Teresa Anderson and Linda Landry, California State Interagency Coordinating Council; Liz Spencer, Westside Family Resource Center; Cindy Rubin, parent*

In 2019, Darby Rubin, an 18-month-old with the rare chromosomal condition, Trisomy 13, passed away. The systems meant to care for children like Darby and their families failed. But Darby's family

wanted their experience to be the catalyst for change. This session introduces a new resource for families and professionals developed by the California Interagency Coordinating Council on Early Intervention (ICC) in collaboration with Darby's mother, Cindy Rubin: "Darby's Legacy: Best Practices When Serving Families with Infants and Toddlers Who Are Medically Fragile."

### 1.D. Supporting Families in Early Start Experiencing Homelessness

### *Presenters: Karmina Barrales and Leanne Wheeler, California Department of Education; Susie Terry, San Diego County Office of Education*

What are the rights and protections of our students experiencing homelessness in early education programs and what can you do? This presentation will help programs understand the definition and laws centered around homelessness. It will also provide you with strategies and collaboration ideas that can be implemented in your community to serve homeless families in the aftermath of the COVID-19 pandemic and beyond.

### **1.E. Promoting Continued Language Development**

### Presenters: Laura T. Petersen and Julie Rems-Smario, California Department of Education and CA Schools for the Deaf; Michele Bergeron, parent; John Pong, parent

This session will provide an overview of language acquisition in infants and toddlers who are hard-of-hearing or deaf. Participants will learn: what the research reveals regarding short-term and long-term impacts of language deprivation for children under three; why children who are deaf and hard-of-hearing are not experiencing improved language outcomes, despite increased early identification of children with hearing loss; and what Early Start professionals can do to support language acquisition during and after the COVID-19 pandemic.

### 1.F. Part C State Policy Updates: What's New in California

Much has changed since the last time national policy consultant, Sharon Walsh (Walsh Taylor Incorporated), presented at the Early Start Partners Symposium. There is a new administration, new leadership at the Office of Special Education Programs, and new federal initiatives to address the impacts of the world-wide pandemic. Ms. Walsh provides an update on federal action impacting services for young children with disabilities and their families, including federal legislation, regulations and budget activities that impact education, social services, and health care.
