Pursuant to the requirements of Government Code Sections 11346.8(d), 11346.9(a)(1), and 11347.1, the Department of Developmental Services (Department) is providing notice that a document titled "Addendum to the Initial Statement of Reasons for Participant-Directed Services" ("Addendum"), has been added to the rulemaking file and is available for public inspection and comment.

Additionally, pursuant to the requirements of Government Code Section 11346.8(c), The Department is providing notice of changes made to the Participant-Directed Services proposed regulations in Title 17, California Code of Regulations, Sections 57310, 57332, 58886, and 58888, which is in the attached document titled "Second 15-Day Modified Text."

The "Addendum" and "Second 15-Day Modified Text" have been developed in response to comments received by the Office of Administrative Law regarding the rulemaking for proposed amendments to the Participant-Directed Services regulations. Furthermore, the "Addendum" includes a correction to page 2 of the First 15-Day Notice of Modified Text released on February 28, 2022.
