

Service Access & Equity Grant

- \$11M Annual Funding (WIC 4519.5)
 - One-time additional \$11 million for a total of \$22 million
- 398 grants since 2016
- Over 100 active grants with monthly check-ins and collaborations
- Reporting to DDS

- Expanding inclusive employment opportunities for individuals with I/DD
- Increasing a culturally & linguistically responsive service provider workforce
- Creating community partnerships for learning and advocacy
- Improving access to Early Start services for diverse communities
- Cultivating meaningful tribal engagement with the Native American community
- Increasing access to deaf services and resources for self-advocates and families
- Developing culturally and linguistically competent resources and educational opportunities for self-advocates, aging caregivers & new parents
- Advancing person-centered services and supports for foster & transition-age youth, and individuals from the LGBTQ+ community

 - Prepare and upload your documents before you begin the application
- ➤ Consider Budget Restrictions

Grant Objective and Activities

- (1) Each grant has one objective
 - •Examples:
 - Train parents in use of technology
 - Increase Early Start enrollment
- (2) Project activities to meet the objective
 - Examples:
 - Conduct workshops in three counties
 - Host monthly family support groups

Grant Measures

Quantitative Data	Qualitative Data
 Examples: Number of participants Pre/post surveys Comparison of POS expenditures before and after 	 Examples: Comments written on surveys Focus group discussion of barriers Insights from interviews

Standardized Measures - Community Connector

- Participant characteristics
- How Community Connectors are selected and trained
- Outputs from activities
- Services that participants receive before/after
- •Family knowledge gain, confidence to make positive changes for family, any difficulty with accessing services, feelings of connection with community

Grant Budget

- Review Budget Instructions (<u>Attachment C</u>)
- Consider <u>Budget Details and Restrictions</u>
 - Grant will not fund activities already funded by other sources
- One budget per project, regardless of duration
- Complete Budget Narrative
 - A clear and concise budget information will help decision makers

 - 2. Objective Report (Activities Template)
 - 3. Budget Report
- ➤ Submit your application to your RC(s) Refer to Attachment F
- After you submit your application, you will receive an email confirmation from GrantVantage
