NOTICE OF MODIFICATION OF THE TEXT OF PROPOSED REGULATION Regional Center Conflict-of-Interest Regulations Notice of 15-day Comment Period

Government Code Section 11346.8(c) provides that the Department of Developmental Services (Department) may make changes in the proposed regulations, which are substantial, sufficiently related to the initial text as originally noticed on January 11, 2013.
