NOTICE OF MODIFICATION OF THE TEXT OF PROPOSED REGULATION Regional Center Conflict-of-Interest Regulations Notice of 15-day Comment Period

Government Code Section 11346.8(c) provides that the Department of Developmental Services (Department) may make changes in the proposed regulations, which are substantial, sufficiently related to the initial text as originally noticed on January 11, 2013.

The Department conducted a 45-day public comment period for these proposed regulations ran from January 11, 2013 through February 28, 2013. In response to comments, the Department has modified the originally proposed text.

All revisions to the originally proposed (45-Day Notice) rulemaking text are highlighted in yellow and identified by double strikeout of the text to be deleted and double underline of the text to be added. Text revisions in the form DS 6016 and the revised ISOR are highlighted in yellow. Only comments addressing modifications in the text that appear in these noted formats will be considered.
