REASON(S) FOR HEIGHTENED SCRUTINY (HS)

- Setting is located in a building that is also a publicly or privately-operated facility that provides inpatient institutional treatment.
- Setting is in a building located on the grounds of, or immediately adjacent to, a public institution.
- Setting has the effect of isolating individuals receiving Medicaid Home and Community Base Services (HCBS) from the broader community of individuals not receiving Medicaid HCBS.
  - Due to the design or model of service provision in the setting, individuals have limited, if any, opportunities for interaction in and with the broader community, including individuals not receiving Medicaid-funded HCBS
  - Setting restricts individual choice to receive services or to engage in activities outside of the setting
  - Setting is located separate and apart from the broader community without facilitating individual opportunity to access the broader community and participate in community services, consistent with an individual’s person-centered service plan.



**SETTING SUMMARY: COMPLIANCE OVERVIEW**

Due to the design or model of service provision in the setting, individuals have limited, if any, opportunities for interaction in and with the broader community, including individuals not receiving Medicaid-funded HCBS.

The following description of the setting and how compliance is achieved was gathered through a combination of observation during on-site review, interviews with individuals served, interviews with direct support staff, and review of provider policies and procedures.

<b>Reason for Heightened Scrutiny</b>	Setting uses delayed egress devices to delay exit from the facility in addition to having a secured perimeter as part of their program design. The delayed egress system is triggered when pressure is applied to the push bar of the entrance/exit of the secured perimeter. The door remains in the secured position for 30 seconds, at which time it opens automatically.
<b>Compliance Overview</b>	<p>This home is located in a residential neighborhood within the greater community. It is down the street from several shopping centers and restaurants. Prior to admission, the individual served, and their planning team discuss if this setting is appropriate for their needs and wants. It is documented in the service plans for each individual residing in this setting that this home is the least restrictive setting located in the community (rather than an institutional setting) as well as the other options explored. The need for this type of supervision is evaluated at least every six months or on an as-needed basis. In accordance with state regulation, there is a procedure in place at this setting to inform individuals that they have the right to leave the facility as they desire, as well as a procedure in place to support the individual in accordance with their person-centered service plan to leave the facility when desired.</p> <p>Staff support individuals to make decisions regarding what they would like to do based on what is important to them. Staff coordinates transportation to activities based on an individual’s input and to promote integration with their community. It was discussed during an on-site visit that one individual had scheduled for themselves that same week a hair appointment at the salon of the individual’s choice, and staff would be assisting them in getting to their appointment. Individuals in the home are able to visit with families and friends with no restrictions, both inside the home and in the community. Individuals have stayed overnight with family and gone on family vacations as well. Staff encourage individuals to maintain relationships with their families and friends. Individuals are supported and staff help facilitate in going to the church of their choice, if desired, in putting together neighborhood barbeques, and in participating regularly in local community events.</p>



	<p>Staff maintain personalized profiles of each individual containing their preferences (activities, food, restaurants) and hobbies, developed with the individuals and their chosen circle of support. The individuals residing in the home get together at least weekly to discuss plans for the week and how staff can be available to support them in going where they want to go and doing what they want to do. Individuals have the choice to stay home at any time, including during the weekday if desired to stay home from their day program.</p> <p>Each individual has their own bedroom, with a lockable door. Appropriate staff have a master key in the event of an emergency. Bedrooms are furnished and decorated how the individual decides. Site assessors noted a cozy home-like feel to the home. Individuals have access to food at any time and assist in meal-planning for the home as they would like. Individuals can eat at times of their choosing, and do not need to sit together unless they choose.</p> <p>Staff are trained regularly on implementing person-centered practices and have been trained on the HCBS Final Rule.</p>
