SDF will work with employers in the community to develop industry focused collaborations to increase workforce preparations and employment opportunities. The target population will be individuals who are between the ages of 16-71, receiving regional center services, have identified that they are seeking to work, and self-identify as African-American or Hispanic. SDF will service the following geographic areas: Los Angeles County, Riverside County, San Bernardino County, Imperial County, San Diego County, and Ventura County. SDF will create an employer collaborative in each community we serve so that way we can meet the needs of the employer and the consumer to ensure they are ready to fill the positions effectively. Through this collaborative we will be able to provide hiring events and meet & greets between employers and persons with developmental disabilities to achieve integrated employment. The intended impact is to reduce barriers of bias and stigmas amongst employers and to level the opportunity field for persons with developmental disabilities to obtain competitive integrated employment. As a service provider we have witnessed first hand and heard the experience persons with developmental disabilities face when trying to seek employment which range from low level low wage jobs to simply not receiving interview due to their disability. Most employers make the assumption that due to the persons developmental disabilities that their capabilities are limited therefore they can only do certain jobs. SDF wants to be the community based organization that bridges the connection to employers and persons with developmental disabilities.

Applicant Response:

Employers have biases and preconceived notions about persons with developmental disabilities. They believe that our individuals are not capable of doing certain jobs or they force them into the jobs they see fit based upon their disability. SDF will tackle this issue directly with employers by making community connections and developing a collaboration in which we will inform them of the abilities, talents, supports, and benefits of hiring a person with developmental disabilities.

Applicant Response:

SDF will seek employers from all industries to bring into the employer community collaborative to help our diverse participants from all backgrounds achieve their employment goals. By having employers from diverse industries it will align with our diverse target population of persons with developmental disabilities, between the ages of 16-71, that identify as African-American or Hispanic to have the opportunity to explore any industry of choice so that they might get the change to explore outside of their backyard. The individuals we serve have expressed that people feel that it is easiest and best for them to remain in their community but they want to experience the same employment experience as persons without disabilities such as working outside the city they live in, have various jobs in different industries, and working amongst diverse populations of persons without disabilities. Employers get individuals from diverse backgrounds and our individuals will have diverse employers.

Project Objective: Develop an ongoing employer collaborative collective to create more opportunities for the employment of individuals with intellectual and developmental disabilities.

Innovative Methods: SDF will use its current employer connections to develop an employer database bank of employers that have hiring needs and need to employ persons with intellectual/developmental disabilities or they need to meet a federal requirement of hiring a person with a disability. This will create a direct connection of supply and demand but also decrease barriers to employment for persons with disabilities, increase opportunities for persons with disabilities, offer diverse employment opportunities for persons with disabilities, and give persons with disabilities gainful competitive integrated employment.

Activities included but not limited to:

- Recruiting employers from diverse industries
- Hosting job fairs/ Pop up direct hiring events
- Assisting employers with connecting 1:1 with candidates with developmental/intellectual disabilities to inform them how to apply and obtain employment in their industries or with their organization.
- Hosting round tables for employers to speak with persons with disabilities to determine how they can be more inclusive and disability supportive in the workplace.
- Host informational workshops on the benefits of hiring persons with disabilities.
- Host seminars/trainings with employment services vendors on the types of supports they provide persons with developmental/intellectual disabilities from searching to obtain a job to job retention.

Input from community/target population: SDF did a survey of our current participants that fall into our target population (persons with developmental/intellectual disabilities receiving regional center services between the ages of 16-71, identify as African-American or Hispanic, desire to work) to find out what the barriers to employment were when it comes to employers and these are the results we received.

- 68% stated that they do not feel that employers give them the same job opportunities as persons without disabilities.
- 79% stated that they do not disclose in the interview process that they have a disability for fear it may disqualify them from the job.
- 91% stated that they would like to have diverse employment opportunities just as persons without disabilities.
- 45% stated that they would like to explore employment opportunities outside of their neighborhood.
- 84% stated that would like to have direct employment opportunities specifically for persons with developmental/intellectual disabilities.

Individuals from the developmentally/intellectually disabled African-American and Hispanic populations have voiced that they experience the most barriers to employment due to their disability and race. They feel that due to their geographical placements that the opportunities that surround them are very limited compared to persons that identify as white and live in middle class communities.

SDF will continue its project work after the grant funding has concluded by having employers pay a membership fee as well as vendors to sustain the opportunities the community employment collaborative brings to individuals with developmental disabilities. Through the membership fees we will be able to ensure all the projects activities continue and maintaining solid partnerships with employers in the community to continue employing individuals with developmental disabilities. I have spoken with big companies such as: Amazon, Starbucks, Google, Netflix, Apple, and Tesla and they all expressed that they want to employ more individuals with developmental disabilities but they don't know how to attract those individuals.

SDF will request to be vendored for PIP and CIE from the regional centers we serve for future sustainability of the projects and the individuals served. As the developer of the employer community collaborative SDF essentially is the agency that obtained the employment for the individual client. The service provider bringing the individual/s to our events will be the employment service provider providing job the vendor bringing them to our hiring events, community outreach collaborations, and our job specific preparation informational will be providing the support to maintain employment.

I started out as a DSP, Behavior Specialist, Community Integration Consultant, Employment Specialist/ Employment Resource Developer, and then venturing off to become a Service Provider. SDF mission is to enrich the lives of individuals with developmental disabilities to become independent and thrive as pillars of their community. SDF provides independent facilitation services, Independent living skills, Supportive living skills, Social Skills, and Adaptive Skills to its program participants. The services we provide are strictly for individuals who are regional center clients and have expressed a need for the services we offer. Our tie to the target population is direct and everyday because the individuals we serve are between the ages of 16-71, receive regional center services, and are African-American or Hispanic.

SDF supports our selected target population of individuals with developmental disabilities through our current services under SDP. The individuals we work with have all expressed a desire to work or do work. Our individuals that have jobs we have assisted them with on the job advocating to ensure they get the supports/accommodations they need to be successful.
