A. Comprehensive System of Personnel Development (CSPD) and Public Awareness \$1,715,000

The allocation for this component represents the portion of CSPD activities conducted under the direction of the lead agency through a contract with the California Early Intervention Technical Assistance Network (CEITAN) project at WestEd. The following components are included in this contract:

1. Personnel Development

- Continue delivery and expansion of online training modules to provide training for a wider, more
 diversified audience on an ongoing basis through an accessible, adaptive system. Curriculum is
 based on early intervention personnel competencies developed in collaboration with
 representatives of higher education, professional organizations of the various disciplines
 identified in Part C, and family resources and support leadership.
- Provide collaborative or fee-based professional development events, in-person or online, for Early Start service coordinators, service providers, and family support professionals,
- Produce training materials and service implementation guidance, aligned to regulations and reflecting recommended and evidence-based practices, for the professional development activities of Early Start managers and service personnel at the local level.

2. Public Awareness and Central Directory

- Make recommendations on creative strategies and activities for outreach to targeted Early Start populations as needed.
- Assist in the analysis, development, and dissemination of Early Start materials.
- Maintain and manage the CSPD website (a.k.a. Early Start Neighborhood) hosted by WestEd and linked to the state's Early Start website listing public awareness activities, outreach resources, and professional development activities and resources.
- Host and maintain the online Central Directory of early intervention resources, providing information to link families and professionals to Early Start partner agencies in their communities. Agencies are searchable by county and agency type.

3. Consultation and Other Contract Tasks

- Provide technical assistance to DDS based on identified state priorities for the implementation and improvement of the Early Start program.
- Assist DDS to support and facilitate interagency collaboration through activities identified by the lead agency and inclusive of support to the Interagency Coordinating Council.

DDS allocates Part C funds through a contract/interagency agreement with the Office of Administrative Hearings, Department of General Services, under the Secretary of State and Consumer Services Agency,

to conduct state-level mediation (if requested by the family) and due process hearings, and to provide records of the proceedings along with written decisions for families served in the Early Start program.

C. Early Start Family Resource Centers (FRCs)

Parent-to-parent, family support is an important component of Early Start in California. FRCs provide parent/family support in a non-clinical family-centered atmosphere. They also assist in fulfilling an information and referral function. In providing parent-to-parent support, FRCs understand the emotional needs of families, and provide assistance in understanding the local service process and transition procedures. The FRCs provide a foundation for family and professional collaboration, promoting positive relationships and joint problem solving in early intervention services.

FRCs also assist in local public awareness efforts and often fulfill the initial information and referral function with locally publicized toll-free telephone numbers in English and Spanish. FRCs have a large cadre of parent volunteers of differing backgrounds and ethnicities that represent the people that live within their communities. They assist with outreach to the populations often hardest to reach, which may include racial and ethnic minority groups, low-income, inner-city, and very rural populations.

A. California Department of Education – Local Educational Agencies (LEAs) \$14,244,871

In California, infants and toddlers from birth through two years of age with solely low incidence disabilities: vision impairment, hearing impairment, severe orthopedic impairment, or any combination, thereof, who are not eligible for services under the Lanterman Developmental Disabilities Services Act are served by Local Educational Agencies (LEAs). The California Early Intervention Services Act established a statewide mandate for LEAs to provide early intervention services to infants and toddlers with solely low incidence disabilities who do not qualify for regional center services. In order to meet the needs statewide of unserved infants and toddlers with solely low incidence disabilities, existing LEA programs were expanded or initiated, as needed, during the first year of full implementation of Early Start. In developing new programs or planning expansions, LEAs and regional centers considered private service programs and evaluated contracting for services. In addition, funding for regionalized services, program specialists, books, materials, assistive devices, equipment, specialized services and others who provide specialized services to students with low incidence disabilities are included in the funding estimate for LEAs. The expense of additional marginal impacts of Early Start (timelines, assessments, IFSPs, and service coordination/interagency coordination) for the population to be served by LEAs is also included in the proposed expenditure.

LEAs are required to receive and act on referrals for services, perform evaluations, conduct assessments, deliver early intervention services, and develop IFSPs in accordance with federal regulations. In addition, LEAs are required to report information that satisfies the federal Office of Special Education Programs and the California Department of Finance data reporting requirements.

The CDE will allocate federal early intervention funds under Part C of IDEA received from DDS to comply with the State and Federal statutes and regulations. In addition, CDE will collaborate with DDS on transition requirements from Part C to Part B services, and coordinate and provide input to applicable State regulations.

B. Department of Developmental Services – Regional Centers

\$33,755,432

Regional centers are required to conduct child find activities, receive and act on referrals for services, perform evaluations, conduct assessments, develop IFSPs in accordance with federal regulations, and coordinate the delivery of early intervention services. The regional centers are considered the payer of last resort for services to all infants and toddlers entering the Early Start service system who do not have a solely low incidence disability.

The funds allocated to regional centers under this part address the increased cost for direct services due to the implementation of Early Start. Costs due to the implementation of Part C in California far exceed the Part C allocation. This impact over and above the Part C funds is born by the State's General Fund, Medicaid, and Early and Periodic Screening, Diagnostic and Treatment (EPSDT).

California's Department of Developmental Services contracts with 21 private, not for profit corporations to operate regional centers throughout the state which are responsible under state law for coordinating, providing, arranging or purchasing all services needed for eligible infants/toddlers and their families under the Early Start Program.
