Amigo Play App will provide Education and Training and improve access to Early Start services, resources and education for diverse and marginalized communities in Tri-Counties RC and Kern RC catchment areas.

The app includes an initial developmental screen in all areas of development (Cognitive, Language, Gross Motor, Fine Motor, Socio-Emotional and Self Care). As the parents are using the daily activities and responding to the performance, new activities are presented at a higher level of complexity. Every six months, we will be able to obtain the new developmental levels of the child based on the parents responses to their daily activities. The anticipated progress will be at least of 6 month on each domain to prevent any further delays, and hoping to an increase of more than 6 months chronological. All the developmental activities were design considering cultual appropriateness and also the language used to describe the instructions. The activities are paired with videos to make it easier for the parents to implement. Last, each activity is supported with an explanation of the importance and how it helps developmentally. The developmental baseline under each domain will be obtain and also the percentage of progress at every 6 months intervals.

The app provides live interactive developmentally related classes and previous classes archives for the parents to see at their convenient time. During the 18 months of the grant process, approximately 30 classes will be completed. Each class will be delivered in English, Spanish and Mixteco. The format of the classes include a video and then an open forum of question and answer to support families with plain language. The classes will be determined based on the experience of frequent challenges observed by parents receiving early start services with Amigo Baby, Inc.

Amigo Baby, Inc has been providing Early Start services to monolingual Spanish and Mixteco speaking Hispanic families for the last 19 years in Ventura, Santa Barbara, San Luis Obispo and Kern Counties.

Amigo Play App will provide education, training and improve access to Early Start services, resources and education for diverse and marginalized communities in Tri-Counties RC and Kem RC catchment areas. Amigo Play App project will target families who were referred to early start and speaks Spanish and Mixteco and are marginalized families. The app has three main areas:

- 1. The app includes an initial developmental screen in all areas of development (Cognitive, Language, Gross Motor, Fine Motor, Socio-Emotional and Self Care). As the parents are using the daily activities and responding to the performance, new activities are presented at a higher level of complexity. Every six months, the app will be able to obtain the new developmental levels of the child based on the parents responses to their daily activities. The anticipated progress will be at least of 6 month on each domain to prevent any further delays, and hoping to an increase of more than 6 months chronological. All the developmental activities were design considering cultual appropriateness and also the language used to describe the instructions. The activities are paired with videos to make it easier for the parents to implement. Last, each activity is supported with an explanation of the importance and how it helps developmentally. The developmental baseline under each domain will be obtain and also the percentage of progress at every 6 months intervals.
- 2. The app provides live interactive developmentally related classes and previous classes archives for the parents to see at their convenient time. Amigo Play has been in contact with Tri-Counties Regional Center and Kern Regional Center for the collaboration and implementation of the Project.

Applicant Response:

The grant funding will help demonstrate an improvement in equity and decrease disparities to families receiving Early Start in Tri-Counties RC and Kern RC.

The App will decrease the knowledge gap caused by multiple barriers among the parents who have a child in Early Start and help build equitable services and prevent ongoing services after 3 years of age. The results attached for POS for TCRC and KRC show cost per individual child under 3 years of age at TCRC for Spanish speaking higher expenditure per capita. At Kern RC the per capita expenditure for under 3 years is less for Spanish speaking consumers. Being or near equal might not be enough to assure the adequate development based on the high level of barriers to developmental knowledge. In addition, in most homes, both parents are working long hours and most of the early start services are delivered to babysitters.

The app will help improve the knowledge gap the parents have when they are available after work. The families that speak Mixteco are receiving in most of the cases the services in Spanish or with basic translation to Mixteco. It will include translations to Mixteco Language as there is no written language. Amigo Play app will also improve the access to education for marginalized communities.

DDS will be able to demonstrate an increase in the percentage of services utilized by UCI. Amigo Play app will request the signature of consent to share data between Amigo Play and DDS.

Amigo Play App is a unique innovative project that includes current access to technology, software development and knowledge in best practice to early start. The App has been developed uniquely considering cultural and linguistically appropriate needs of the families.

The technology uses the phone or tablet the families are already familiar with. It will not require the use data plans as they can download the app and all the programs can run except for the live classes. It has been developed using IOS and Android operating systems that are the majority of the devices of the families. The families will be able to download the app from the apple store or Google play for free using the UCI number to set up the user.

The software developed used pilot groups to determine design and wording to make it culturally and linguistically appropriate. In addition, the app has videos on the activities to make the process simpler for the viewer to implement.

The developmental knowledge and activities were developed using well developmental milestones accepted by the American Academy of Pediatrics and CDC.

4. Applicant Question: Improve Equity and Service Access

Applicant Response:

Amigo Play App will improve equity and service access to the families receiving Early Intervention at TCRC and KRC catchment areas by making the app free to all families using the UCI to set up the account for free.

The app will be downloadable on the device the family is already familiar without the need to purchase a new one and will no additional cost. The app has been developed in English, Spanish and Mixteco to reduce language barriers and help the families understand the Early Start knowledge in their own language. The activities included in the app requiere either home made or inexpensive materials. Videos are used to show the implementation of activities and during live sessions to assists the families engage and understand the information by imitation. The app allows the parents to complete the activities and see the recorded classes at their available time and removing barriers to parents that have to work long hours.

Clinical Services, Karina Proffer, Lilia Ran Multicultural Specialist and Michi Gates, Executive Director to support the project. The plan will be
to educate the Service Coordinators serving Early Intervention in each Regional Center about the value the App brings to the children so they can
promote it among their families and decrease barriers to service and knowledge to build the parents competence.

Amigo Play will collaborate with Rainbow Connection FRC and Project Access to make the live classes available to as many families participating as possible. Project Access will be completing the translation of all the videos to Mixteco language and the Rainbow Connection FRC to all their network of parents and post on their social media.

AmigoPlay will have the follow the activities in the numbered order. Hiring the correct Project Director will assure the follow up to all the other eight activities stated to meet the Objective: "AmigoPlay Application will improve access to Early Start services, resources and education for diverse and marginalized communities."

Amigo Play app has been developed for the last three years taking into consideration cultural and language appropriateness to assure family participation. The app has been in Beta testing during the 2022 year with focus groups to assure functionality in the different languages.

Usage:

The app will track the amount of logins of the users, and be able to determine the average length of time the app is open. The app will be able to track the primary language of the users to determine if their primary language is English, Spanish or Mixteco and determine the percentage of all the users enrolled. The app will capture the amount of users enrolled, and the amount of active users during the previous months.

Developmental activities:

The app has a developmental screening that every user will complete the first time they use the app based on their child. The answers will help establish the baseline under each developmental domain. The app will presents in their language activities, video instructions, and importance of doing it for the long term success of the child. The app will measure the average months of progress after 6, 12 and 18 months of usage under each domain.

Live Classes and Recorded Classes

The app will record the number of users signed for a class. It will present a pre and post test survey to determine the knowledge gained. The questions posted to the chat will be answered and available for review as part of the Q&A of each class. The app will allow access to previous recorded classes. The person that will be viewing the recorded class will complete the pre and post survey to determine the increase in percentage of knowledge gained.

Request for services and/or generic:

The App will be able to generate the baseline regarding the amount of services and generic resources the family is participating. The app will be able to track on a quarterly basis the the amount of services the family has been enrolled during the quarter using a survey. If the family is requesting additional support, the PD will be able to individualize the support. The initial survey will also determine the services being provided by TCRC and KRC at the beginning and also at 6, 12 and 18 months. It will work to promote equity and decrease disparities for some of the minority communities.

The above measures will allow provide the data to determine the effectiveness of the app.

The cost of other services will continue to be assumed by Amigo Baby, Inc, the parent company like: additional software development, office rent, presenter wages, and web-hosting.

The role of the PD will be to assure good user experience and support, coordinate with the therapist the live class participation, schedule of classes, coordinate all video production, assure all videos are in the right language for the presentation, support the presenters during the live sessions to make sure all questions posted on the chat are answered, work with the developers to obtain quarterly all the data needed to support the measures to comply with the Grant requirements.

The PD will coordinate with the Service Coordinators and local Family Resource Centers presentations to help families receiving Early Start services understand the value brought to the families and assists with family enrollment.

The PD will respond to service requests and contact the families by phone or email depending on the family preference. The PD will be knowledgeable of the local resources in each of the four counties that represent TCRC and KRC catchment areas and support with education and guidance when the families request the service.

On a quarterly basis the PD will be able to complete all data requested by the grant and at the end of the 18 months preset the final report.
