Applicant Response:

The previous project started in March of 2022 and will run through the end of February 2023. During the initial seven months, several key deliverables have so far been accomplished:

- 1. Established a bi-weekly birth-3 playgroup that has been operational for 5 consecutive months and continues presently; conducted variety of promotional activities to increase family access to and participation in playgroup.
- 2. Established a developmental referral and screening protocol within the Indian Health Clinic such that physicians and other medical providers can schedule a follow-up appointment with the project clinician in real time during their encounters with families.
- 3. Conducted 14 screenings at the clinic as a result of new referral protocol
- 4. Conducted 2 assessments.
- 5. Provided ongoing pre-referral direct intervention to 4 hesitant families.
- 6. Trained and provided Early Start referral forms and brochures to clinic medical providers in Early Start referrals, including informal screenings, and direct referral.
- 7. Screened and assessed 6 children under 5 years of age through word of mouth referrals from community partners resulting in 2 referrals to Regional Center.
- 8. Distributed 44 developmental play kits including books, toys and parent-friendly written guidance on developmental milestones and promoting early development.
- 9. Provided direct support on-site to the school district preschool staff to facilitate identification and referral of students of concern.
- 10. Conducted outreach activities and networking at community events including the monthly Food Bank distribution day and an all-day community training on the topic of Native-informed Trauma Care
- 11. Corresponded with 3 potential candidates in search for finding a trainer to present to the early start workforce on considerations of service delivery in Native American communities.
- 12. Identified and initiated contact with 2 new additional community partners, ICWA and Yuki Trails (behavioral health clinic).

The project seamlessly continues into Year 2 with continuation of current activities and measures. Expansion activities are also proposed and described below, based on the knowledge gleaned from the first 7 months of project implementation.

- Expand the project scope to include identification and referral of 3-18 year old children for Lanterman services in addition to Early Start, based on the number of 3+ year old children identified thus far as un- or under-served.
- Increase the birth-3 playgroup frequency from every-other week to weekly, with anticipation of increased attendance with a weekly option for families.
- Build collaboration with newly identified community partners: ICWA (on any given day there are an average of 75 youth in ICWA-supervised foster care), Yuki Trails (Indian Health Clinic's youth and adult behavioral health program). Partnering with these agencies will afford opportunities to promote infant/early childhood mental health awareness and generate warm-handoff opportunities for foster caregivers to receive Regional Center assessments and services.

The current proposed project builds upon already existing resources within the region. The requested funding would be used to expand and strengthen child find capacities among local staff interfacing with children and families. By the end of Year 22-23, we expect that: local staff will be independently conducting child find activities, be fully stocked with Regional Center brochures and referral forms, and feel competent and skilled in making referrals independently; families will have increased awareness of early childhood developmental skills, familiarity and trust in Early Start personnel, and overall increased likelihood of following through with services for their children. We expect that the birth-to-five developmental play group will have been established and staffed and able to continue independently. The successes of the project will serve as a model for replication in other communities with similar barriers.

Purpose: To increase the access to and quality of Redwood Coast Regional Center's Early Start services in one under-resourced, geographically isolated, primarily Native American Tribal community in Mendocino County: Covelo. To serve as a potential model for replication in communities with similar barriers.

Background: Current POS-based Early Start services are failing to meet the unique needs of one of the most culturally diverse, poor, isolated communities at high-risk for childhood developmental needs. Early Start providers come from out of town, are limited in availability, are sporadically present due to POS driven services, and are often met with mistrust by families; culturally competent providers are not always available; the natural environments model of service delivery is often inappropriate for families that do not want services at home, and there is a lack of appropriate community meeting spaces; traditional provider service constraints are an obstacle for families with life stressors that require more flexible scheduling options.

Focus: Increase Covelo community awareness of and trust in Early Start services via funding a dedicated, consistent, culturally-competent, bilingual Early Start clinical professional to establish a community presence two-to-three days per month for two years. Provider will partner with community agencies to decrease barriers to acces, conduct an array of service delivery models, and provide training to community resources for sustained child-find activities and enhanced developmental awareness.

Area of need: RCRC identified the need to increase disproportionate POS utilization among families with infants and toddlers in Covelo.

Organizational Experience: The project seeks to fund an Early Start clinical professional with extensive history working with marginalized and diverse communities, and an existing relationship with Covelo community partners and families.

Goals: 1) Increase community trust and knowledge of child development through the consistency and familiarity of a dedicated provider. 2) Increase local agencies' staff capacity for parent education, screening, identification, and referral. 3) Increase local childcare providers' capacity to support children with disabilities and their families. 4) Increase cultural competency of county Early Start workforce for working in Native American communities.

Applicant Response:

We conducted multiple interviews in Covelo over a span of 6 months in 2021 with parents of children with disabilities, Head Start leadership and staff, school district special education leadership, health clinic providers, and FRC management to learn what rates and types of disability are being seen, what barriers exist, and what supports community members say they need to improve access. Interviews supported established RCRC data showing disproportionately low access to Early Start. Local preschool teachers and Round Valley School District special education leadership reported that 20-55% of children age 3-5 in preschool are identified after age 3 with significant needs and resultant IEP's. Current Child Find activities in Covelo are reaching a fraction of children under 3 that have significant delays and disabilities. Of the children identified, family responsiveness to IFSP services is well below average.

Applicant Response:

Our project specifically targets one isolated and underserved Native American community that has an historical mistrust of outsiders and government services. We employ the unique strategy of placing an Early Start clinical professional directly in the community on a consistent, frequent and sustained basis over the course of two years to overcome barriers to access via family endorsement through partnership with trusted community leaders, relationship-building, trust-building, and capacity-building within organizations that work with children and families. RCRC's current 2021-2023 MHSA "F.A.S.T." grant broadly targets social-emotional health of birth-to-five age children across the 4-county catchment area and has also identified Covelo as an area of specific, high concern. RCRC has a Diversity Grant through which it provides outreach to local Native American and Latino communities.

Applicant Response:

RCRC covers 4 rural counties in the Northwest portion of California, which are among the poorest, least resourced and most geographically challenged areas in the state. We serve a culturally diverse population with high needs (e.g. significant incidence of Fetal Alcohol Syndrome, pre-natal toxic exposure to meth, repeated years in which the area has experienced Federally Declared Natural Disasters- Fire and Flood). Infants, toddlers and young children are particularly disadvantaged by poorly developed healthcare, educational and family resources. Collaborative partnerships to provide a strong network of support in our local area are particularly needed, as individuals may be several hours away from more populated and better resourced towns and cities. RCRC's catchment area includes a significant Native American population. Development and delivery of culturally appropriate services and approaches to serve this community has been a barrier. This grant will facilitate, introduce and expand services and supports which utilize the strengths and honor the traditions that are unique to this population. This project will expand RCRC partnership with local Covelo medical, childcare, educational and family resource centers.

Applicant Response:

We are recommending that the Objectives and Measures from Year 1 of the project continue into Year 2 without modification. This reflects the goal of the work of the project in taking time to establish itself in the community and for the project staff to become familiar and trusted partners in the community.

The project proposes to concurrently target its component activities from the beginning throughout the lifespan of the project. The activities mutually enhance each other, but none are contingent upon another.

Applicant Response:

This project is designed to minimize cost through the use of a single staff person who has already completed extensive research and development on the ground in the community in order to develop this project. This keeps costs limited to those associated with being up and running, versus preparing and planning. Costs are limited to direct personnel and supply expenses. We are requesting an increased budget this year chiefly to allow personnel the actual time required for carrying out the project activities implementation and the project administration. The Y1 project proposal underestimated both the administrative time necessary to manage the grant, as well as the time necessary in the community to conduct all of the activities. The Y2 budget proposal aims to rectify these errors that were discovered in the process of Y1 of the grant being carried out.

The primary budget change this year is increasing from 26 workdays in Y1 to 52 workdays for the 2023-24 year. In addition to providing adequate time for project implementation and administration, Year 1 activities revealed community-specific factors that call for the need to be physically present on as frequent as possible a basis as the most critical means of conducting meaningful outreach. Such factors include:

- Weekly presence will allow greater flexibility for missed appointments, family realities, cultural reality of appointment follow-through.
- Unexpected closures: All tribal offices programs close for at least one day when a tribal member passes away. Little to no notice is available.
- Geographically-based disruptions to scheduled activities such as power outages, internet outages, slides/accidents/road closures. These are common parts of life there, and grant clinician needs to be able to pivot to alternate tasks and activities when blocked from the planned or intended intended ones.
- Incidental and spontaneous conversations with community members are a critical part of outreach. The clerk at the grocery store, the gas station cashier, the parent dropping off at prek who wants to talk about their niece/nephew/neighbor's kid, the person in the parking lot at the clinic... These are the unplanned yet essential moments in a community of this size that build awareness of the Early Start presence, the person who can guide them through the process, and trust that this person will be available to them reliably.
- Project personnel attendance at community events where critical connections with can be sparked, which often occur on a weekend, evening or day when other grant activities do not take place.
