Service Access & Equity Grant

- \$11M Annual Funding (<u>WIC 4519.5</u>)
- 450 grants since 2016
- Annual Guidelines with input from community partners
- 100+ active grants with regular check-ins, collaborations, and quarterly reporting
- Grants managed online with ongoing technical support and training for grantees
- Monthly CBO Engagement Meetings

2023-24 Grant Priorities - Highlights

- Improving timely access to Early Start services for diverse and marginalized communities
- Cultivating meaningful engagement to increase access to culturally and linguistically competent services
- Creating diverse community partnerships for learning and building collaboration between persons with I/DD, families, service providers, and RCs

Grant Objective and Activities

- (1) Each grant has one objective
 - Examples include:
 - Training parents to use technology
 - Increasing Early Start enrollment
- (2) List project activities to meet the objective
 - Use Standard Activities when possible:
 - Host support groups
 - Conduct workshop sessions & collect standard pre/post workshop data
 - Refer to <u>Attachment B</u> for more examples

Grant Measure Examples

Quantitative Data	Qualitative Data
 Number of attendees at workshops Number of RC services before/after program Pre/post surveys with number scores 	 Success stories from families Comments on openended survey questions Insights from interviews

Standardized Measures - Required for All Projects

- ➤ Grantees must review all requirements in <u>Attachment B</u>
- >Standardized Measures
 - Required for all projects
 - Assigned by project type

<u>Education & Training – examples</u>

- Number of participants attending sessions
- Pre/post knowledge gain
- Follow-up survey

- <u>Community Connector examples</u>
 Participant-level data such as demographics
 - Services before/after program
 - Pre/post survey

Grant Budget

- Review Budget Instructions (<u>Attachment C</u>)
- Consider <u>Budget Details and Restrictions</u>
 - Grant will not fund activities already funded by other sources
- Complete Budget Narrative
 - A clear and concise budget with relevant information will help decision makers
- One budget per project, regardless of duration

Final Steps

- Download your application which includes:
 - 1. Application Report
 - 2. Project Plan Report (Activities Template)
 - 3. Budget Report
- Email your application to your RC contact listed in <u>Attachment F</u>
- After you submit your application in GrantVantage, you will receive an email confirmation from GrantVantage
