# PRACTICE GUIDES FOR FAMILIES

As a parent or caregiver, you are your child's first and best teacher. <u>The Division for Early Childhood (DEC)</u> <u>Recommended Practices</u> can help you support your child's developmental needs, and support partnership with professionals to achieve your family's goals for your child. # THE LEARNING CORNER

#### **First Five California**

Learning self-regulation in early childhood (0 to 5 years) is important to children's development. First <u>5 California</u> provides a <u>simple list</u> of the milestones of age-appropriate social and emotional skills in young children.

#### California Children's Services (CCS) Program

The state of California CCS program provides additional services for children, under age 21, who have CCS eligible medical conditions. Common examples of eligible conditions include sickle cell anemia, hemophilia, and aplastic anemia. Search your <u>local CCS</u> office.

#### Women, Infants and Children (WIC) Program

The WIC program is available for women (pregnant, breastfeeding, post-partum) and children up to five years old may qualify. For tips on good nutrition practices and eligibility requirements visit <u>California WIC</u>.

## **DARBY'S LEGACY**

On August 21, 2017, Darby Jean was born with Trisomy 13 (Patau Syndrome). Her syndrome led to medical complications and developmental delays. While Darby received great care in the hospital, her parents struggled to get her timely services and supports post-discharge. Darby's experience shone a light on ways California's service delivery system for medically fragile children can be improved. # UPK Universal California's PreKindergarten Great Start

## **UNIVERSAL PREKINDERGARTEN: CALIFORNIA'S GREAT START**

<u>Universal Prekindergarten (UPK)</u> is the expansion of the state's mixed delivery system to meet the early education needs of three- and four-year-old children and their families, including Transitional Kindergarten will be available for free to all four-year olds by 2025-2026. UPK is an important part of a statewide effort to provide whole child support for children and families and transform California's schools to be more community-focused and equitable. UPK implementation will look different across California's many regions. Partnerships with local tribal nations and community groups are necessary to build successful UPK programs.



# THE EARLY START NEIGHBORHOOD

The Early Start Neighborhood provides a "home base" for Early Start professionals and partners seeking training, technical assistance, and resources on early intervention Part C requirements, implementation, and evidencebased practices. This site is hosted under the Comprehensive System of Personnel Development and Resources (CSPD-R) contract, sponsored by the California Department of Developmental Services (DDS) and managed by the California Early Intervention Technical Assistance Network (CEITAN) at WestEd.

#### DEAF & HARD OF HEARING RESOURCES

LEAD-K Family Services functions as the current Early Hearing Detection and Intervention (EHDI) program in California. Lead K's centralized services focus on connecting families with their local school district, Early Start home visit teachers, parent mentors, Deaf coaches and other supports as outlined in an Individualized Family Support Plan.

Language First aims to educate and raise awareness about American Sign Language (ASL)/English bilingualism and the importance of a strong first language foundation for Deaf and hard of hearing (DHH) children.

# CALIFORNIA TEACHING PYRAMID FOR FAMILY CHILD CARE

WestEd, in collaboration with the California Department of Social Services- Child Care and Development Division, is accepting applications for a <u>comprehensive professional development</u> <u>package</u> for family childcare providers (educators) and family, friend, and neighbor providers who provide care for children birth to five years old in 2024. This experience includes materials and is offered at no cost to those who have their applications accepted.

There are 10 evening training sessions held virtually (on-line), 3 coaching visits in your home, and 3 reflective practice cadres in whatever manner (virtually or in-person) works best for the group.

Applicants must be able to commit to participation in all three separate components:

1. Training: California Teaching Pyramid for Family Childcare Virtually on 10 evenings. Monday & Wednesday: 6 pm to 9:15 pm.

- Module 1a: January 22 & 24, 2024
- Module 1b: March 18 & 20, 2024
- Module 2: May 20 & 22, 2024
- Module 3a: July 22 & 24, 2024
- Module 3b: September 23 & 25, 2024

2. Coaching visits in-person for ninety-minutes to 2-hours.

• Dates will be set with each participant after Module 1a, Module 2, and Module 3b.

3. Reflective Practice Cadres: Three 2-hour sessions.

- Dates will be set after Module 1b, Module 3a, and after the final coaching visit after Module 3b.
- Applicants will be screened based on their commitment and geographic distribution.
- Those who are accepted will be notified of their acceptance into the cohort by January 8. Others will be placed on a waiting list or invited to a future professional development opportunity.
