TO: REGIONAL CENTER EXECUTIVE DIRECTORS

SUBJECT: RATE REFORM – SERVICE CODE CROSSWALK

As recommended in the 2019 Rate Study, rate reform includes standardization of service requirements and service codes. Each service description is tied to a service code, with subcodes for all associated variations. Some service codes will remain unchanged, others will be adjusted to incorporate multiple service codes or subcodes, and some will be phased out.

Below is a list of the service codes that will be phased out and the service codes to consider as a possible match to the services currently being provided. This list does not include all options and other service descriptions to which services actually delivered may align.
