Longc nyei za'eix yiem 2023-24 caux wuov ndaangc hingv nyei sou-box se ganh nyungc maiv doix longc nyei za'eix caux sou-daan longc mbenc ndaangc maengx nyei sou-box. Beiv mangc taux ndaangc maengx nyei sou-box se oix zuqc faix fim, caux kungx oix zuqc naaic Gorn Zaangc.

#### 1. Hnyangx-Dong POS Sou-Box hnangv haaix lengc caux [Pouh Tong Hungh Heic Bieqc Hnyouv Zaamc fai "Public Comprehensive Dashboard"](#)?

Nyungc baac lengc nyei jauv se liemh jienv:

- Hnoi-nyieqc: Pouh Tong Hungh Heic Bieqc Hnyouv Zaamc duqv mbenc benx hlaax caux liemh jienv yietc zungv dorng hnyangx (FYs) jiex gorn yiem FY 2011/12. Hnyangx-Dong POS Sou-Box hlaau yietc nzunc yietc hnyangx FY.
- Mienh laanh nyei funx:
  - Pouh Tong Hungh Heic Bieqc Hnyouv Zaamc biux mengh gorqc zeic dongh yiem jienv wuov norm hnyangx FY a'fai duqv bieqc POS longc cuotv nyei jauv yiem FY nyei hnyangx-dauh.
  - Hnyangx-dong POS Box longc yietc norm sing yiem ziangh hoc nyei za'eix, funx gorqc mienh benx yiem jienv sou-gorn yiem Zih Hlaax nyei FY hnyangx-dauh a'fai ndongc haaix zoqc yaac yietc POS nyei sou-gorn yiem wuov norm hnyangx FY.

- Nyungc baav waac-fienx yiem Hnyangx-Dong POS Sou-Box se maiv yiem Pouh Tong Hungh Heic Bieqc Hnyouuv Zaamc. Gauh camv nor, sou-daan biux yiem POS nqoi nzuih caux longc nyei jauv can kungx box yiem Hnyangx-Dong POS Sou-Box.

## 2. **Hnyangx-Dong POS Sou-Box hnangv haaix gapv zunv daaih?**

Hnyangx-Dong POS Sou-Box se ganh ca'lengc mbenc benx ganh kang Excel sou-buonv nyei za'eix. Yietc zeiv sou-buonv se liemh jienv camv-yiemc porv mengh zeiv, mbaih ei hoc-dauh. Yietc zungv longc nyei za'eix zorng-mbenc naaix deix sou-box haih doqc mangc yiem [Methodology Overview document](#).

## 3. **Maaih saengv zaangc dingc longc taux naaiv zoux sou-box nyei fai?**

Maaih nyei, saengv zaangc dingc longc taux naaiv zeiv sou-box se an jienv Gorn Zaangc [website](#) yiem RC sou-box.

## 4. **“NoPOS” sou-box se haaix nyungc?**

Hnyangx-Dong POS Sou-Box liemh jienv camv-yiemc “NoPOS” sou-zeiv, caux maaih mbuox heuc “NoPOS” sou-box. NoPOS sou-box porv mengh eix-leiz taux gorqc dongh maiv maaih POS sou-tov yiem FY, yiem ga’ndiev naaiv deix sou-daan qongx.

- Gorqc Zeic nyei Funx: Yietc zungv gorqc zeic duqv zipv tengx yiem RC.
- Gorqc zeic dongh maiv maaih Purchase Services nyei longc cuotv: Yietc zungv dingx laaih, maiv maaih, a'fai gauh zoqc POS nyei sou-daan yiem FY.
- Percent Maiv Maaih Purchsed Services Sou-daan: Percent taux gorqc zeic dingx laaih, maiv maaih, a'fai gauh zoqc POS nyei sou-daan yiem FY.

## 5. **Beu sengh “insurance” sou-box se haaix nyungc?**

Hnyangx-Dong POS Sou-Box liemh jienv camv-yiemc “Insurance” sou-zeiv (nyungc zeiv., InsxLang) dongh porv mengh yiem longc cuotv weic gorqc zeic maaih “co-payments” a'fai ganh nyungc beu seng longc cuotv nyaanh. “Goqc Zeic Funx Jienv” nyei qongx yiem naaiv deix sou-box se kungx liemh jienv gorqc zeic nyei beu sengh longc nyei hnangv.

## 6. **Weic haaix diuc maiv maaih “Yietc zungv” qongx yiem sou-box funx muonc ei zaah daaih?**

Yiem hlaau zunv nyei qongx taux gorqc zeic zaah daaih, gorqc zeic maaih gauh camv zaah daaih haih fiev njiec gauh camv yietc kang. Hnangv naaic, “Yietc zungv” qongx maiv biux mengh yiem horpc nyei waac-saauv weic gorqc mienh.

**7. Maaih haaix nyungc lengc yiem sou-box biux mengh Gorqc Zeic Gorn Za'eix (IPP) nyei faan?**

Hnyangx-dong POS Sou-box liemh jienv 2 zeiv IPP faan nyei sou-box, "IPP45" caux "IPP60", biux mengh IPP nyei tov faan yiem soux mouc a'fai maiv maaih soux mouc waac, nyei bouc. Weic Hnyangx-Dong POS Sou-Box, soux mouc nyei waac se benx cuotv-seix waac ndongc haaix yaac 5% gorqc zeic duqv zipv tengx nyei jauv. Tov IPP faan nyei waac soux mouc waac oix zuqc dau ziangx yiem 45 gu'nyuoz. Maiv maaih soux mouc nyei waac se benc cuotv-seix waac gorngv gauh zoqc 5% ei tengx nyei gorqc zeic mienh. Tov taux IPP faan yiem maiv maaih soux mouc waac oix zuqc zoux ziangx yiem 60 hnou. Weic gauh camv nyei waac-fienx, mangc [kang 1810.410](#) yiem "Title 9 California Code of Regulations" leiz.
