Dear Gloria Wong:

This letter is to convey the results of the Department of Developmental Services' (DDS) review of the Early Start Program at Eastern Los Angeles Regional Center (ELARC). This review was conducted through DDS' Self-Assessment Monitoring (SAM) system on April 5, 2024, through May 23, 2024, to ensure that California meets Part C of the Individuals with Disabilities Education Act (IDEA) requirements.

ELARC completed a self-assessment of 80 records through SAM. This consisted of 40 regular records and 40 transition records. DDS verified the documentation and the findings for each of the 40 records. DDS identified finding(s) of noncompliance in the following areas:

- Obtaining written parental consent prior to evaluations/assessments being conducted,
- Timely written notification to families for the Individualized Family Service Plan (IFSP) meeting,
- Obtaining written parental consent prior to the provision of early intervention services,
- Identification of all early intervention services on the IFSP,
- Timely provision of services,
- Provision of early intervention services in the natural environment,
- Timely completion of IFSP with transition steps and services,
- Timely transition conference (i.e. at least 90 days prior to the child's 3rd birthday).

The details of the findings are in the enclosed monitoring report.

Required Action:

The U.S. Department of Education's Office of Special Education Programs (OSEP) requires the state lead agency, DDS, to verify correction of noncompliance based on the individual child level (prong 1) and the systemic level (prong 2) as soon as possible, and

no later than one year from the date of this letter. A plan, signed by you, addressing the systemic level (prong 2) areas of noncompliance is required to be submitted to DDS within 30 days of the date of this letter.

As part of the plan of correction, ELARC should identify and address the root cause of noncompliance on each outstanding finding. Identifying the root cause ensures that corrective actions are meaningful and effective. Please forward the required evidence of clearance on each of the outstanding individual findings (prong 1) as soon as it is available (if applicable). DDS will require ELARC to provide subsequent records to clear the systemic level findings. In addition, please see recommendations listed on page 6 of the monitoring report.
