

Funding to implement strategies to reduce disparities and increase equity in regional center services

- \$11M Annual Funding (<u>WIC 4519.5</u>) with over 500 grants since 2016
- Annual Guidelines with input from community partners
- Regular check-ins, collaborations, and quarterly reporting
- Grants managed online with ongoing technical support and training for grantees
- Monthly CBO Engagement Meetings

Objective and Activities

Grantees must review all requirements in Attachment B

- (1) Each grant has one objective. Examples include:
 - Training parents to use technology
 - Increasing Early Start enrollment
- (2) List project activities to meet the objective. Use Standard Activities when possible:
 - Host support groups
 - Conduct workshop sessions & collect standard pre/post workshop data
- (3) No need to enter measures

Grant Budget

- ☐ Review Budget Instructions in <u>Attachment C</u>
- ☐ Follow Budget Details and Restrictions
 - SAE will not fund activities funded by other sources
- ☐ Complete Budget & Budget Narrative
 - Keep them clear and easy to understand
- ☐ One budget per project, regardless of duration

Reapplications and Evaluation

Eligibility for Renewal Projects

- Applies to projects awarded in FY 2023-24 and FY 2024-25
- Must continue the same project with a consecutive start date
- Projects with funds already sufficient to continue into 2026 are not eligible

Scoring Criteria

- Exceptional: Clear accomplishments, strong impact, solid plan
- Adequate: Meets requirements, shows progress, reasonable plan
- Inadequate: Lacks progress, impact, or plan

Note: Projects with more than 2 "Inadequate" ratings will not be considered
