

## What is the State Systemic Improvement Plan (SSIP)?

A comprehensive, ambitious, yet achievable multi-year plan for improving results for infants and toddlers with disabilities and their families.

States must select a Stateidentified Measurable Result
(SiMR) that is a child or family
outcome, set annual targets,
and report achievement relative
to those targets.

Plans must include improvement strategies that build infrastructure and implement evidence-based practices.

States must also identify and evaluate progress toward a set of related short- and mediumterm **outcomes**—including measures of **fidelity** to practice, and report on that progress annually.

## California SSIP History

- First plan cycle: 2015-2020, extended two years
- **SiMR:** Child outcome statement 1: "Significant growth in social-emotional outcomes for all children aged 0 to 2"
  - Child receives at least six months of El services through Early Start
- Improvement strategies & activities:
  - "Take a Minute" campaign
  - Checklist of Family-Centered practices for providers

## Why Change the SSIP?

By 2024, the plan was ten years old, without updates

SiMR was too broad: all children across the state were included, while interventions were localized

- Could not attribute outcome gains to improvement activities
   Implementation had waned
  - Evidence-based strategies were not monitored
  - No fidelity data were available

The evaluation plan was inadequate to measure improvement toward the SiMR targets

The advisory group decided it was time to update the SiMR. Convened over the course of several meetings in 2024 to put a plan in place to update the SiMR.

#### SSIP Revision - Requirements

Gathered substantial constituent engagement

Complete data and infrastructure analyses Select the SiMR

Create a Theory of Action

- Identify the improvement strategies (activities)
  - Family-directed Assessment
  - High Quality of IFSP

Designate leadership teams

Design the implementation/improvement plan

Establish an evaluation plan with annual outcomes

#### Phase II SSIP Improvement Plan

#### Improvement Plan

- Implement coherent improvement strategies: Goals, activities, steps with timelines, resources and who's responsible to improve insfrastructure and support locals in implementing evidence-based practices
- Align, partner & leverage existing multiple offices, initiatives and other resources

#### **Evaluation Plan**

- Evaluation aligned to TOA
- Short- and long-term outcomes aligned to Implementation Plan
- Data collection/analysis methods & timelines to measure implementation (process) & outcomes (impact)
- Stakeholder engagement and communication

#### Revised CA SiMR

"There will be an increase in the percentage of families that report early intervention has helped them help their child develop and learn."

**Focus:** helping families help their children develop and learn.

**Reason**: In early intervention, a child's outcomes depend on family engagement and participation in the child's development.

**Reason**: Providers' practices impact families first, so the measurement is closer to the intervention.

**Reason**: Families need support, and the SSIP focus can draw program and public attention to their needs.

## Part C SSIP Theory of Change

#### If Early Start...

**Improves conditions and incentives** for providing high quality EI, and

Builds its infrastructure to support high quality implementation and data analysis in support four focus strategies.

#### Programs and staff will...

- 1) Uniformly conduct high quality family-directed assessments,
- 2) Develop high quality IFSPs
- 3) Implement family coaching universally and consistent with recommended practice, and
- 4) Monitor progress validly and consistently


