008	Sports Club	A regional center shall classify a vendor as a Sports Club service provider if the vendor provides intermittent or regularly scheduled temporary non-medical care in a community recreational setting with equipment and/or instruction to maintain and/or enhance a person's physical health through exercise. Sports Club services include but are not limited to: exercise consultation with consumers and instruction in the use of exercise equipment. Sports Club services will be provided in the following community recreational settings: YMCA, Sports Clubs, Community Parks and Recreation Programs or other community based recreation programs.		
009	Medicare Part D Premium and Medications	A regional center shall classify a vendor as MediCare Part D premiums if the vendor is a CMS approved Part D Prescription Drug Plans/Pharmacy Benefit Managers (PDPs/PBMs) vendored by Central Valley Regional Center (CVRC), or by another regional center upon prior approval by the Department of Developmental Services; and/or Part D medications or co-payments purchased from any regional center vendored pharmacy. Regional centers may also use this service code to reimburse consumers/caregivers for medications excluded from the PDP.		
015	School for the Deaf-Blind	Comprehensive Program for Deaf-Blind Individuals. Includes Evaluation, Training, and Room and Board.		
017	Crisis Team- Evaluation and Behavior Intervention	A regional center shall classify a vendor as a Crisis Team - Evaluation and Behavioral Intervention provider if the vendor provides crisis intervention services designed to support and stabilize the consumer in the consumer's current living arrangement or other appropriate setting (e.g., day program, school, community respite). Crisis Team - Evaluation and Behavioral Intervention includes, but is not limited to: include consultation with parents, individuals, or providers of services to develop and implement individualized crisis treatment, as well as supplemental crisis intervention services.		
020	Transition/Set Up Expenses	A regional center shall classify a vendor as a Transition/Set Up Expenses provider if the vendor provides one-time set-up expenses to assist individuals who are moving from an institution to their own home. These expenses fund some of the initial set-up costs that are associated with obtaining and securing an adequate living environment and address the individual's health and safety needs when he or she enters a new living environment.		
021	Vehicle Modification and Adaptation	A regional center shall classify a vendor as a Vehicle Modification and Adaptation Provider if the vendor provides devices, controls, or services which enable recipients to increase their independence or physical safety, and which allow the recipient to live in their home. Services include, but are not limited to: repair, maintenance, installation and training in the care and use of items provided, modified or adapted and are identified in the consumer's IPP. The manufacturer's authorized dealer must perform vehicle adaptations. The manufacturer's authorized dealer shall perform repairs to and maintenance of such equipment where possible. The following types of adaptations to vehicles are allowable: 1. Door handle replacements; 2. Door widening; 3. Lifting devices; 4. Wheelchair securing devices; 5. Adapted seat devices; 6. Adapted steering, acceleration, signaling, and braking devices; and 7. Handrails and grab bars. Adaptations to vehicles shall be included if on an individual basis, the cost effectiveness of vehicle adaptations, relative to alternative transportation services, is established. Adaptations to vehicles are limited to vehicles owned by the recipient or the recipient's family and do not include the purchase of the vehicle itself. The recipient's family includes the recipient's biological parents, adoptive parents, stepparents, siblings, children, spouse, domestic partner (in those jurisdictions in which domestic partners are legally recognized), or a person who is legal representative of the recipient. Vehicle adaptations will only be provided as a waiver service when they are documented in the individuals plan of care as necessary in order to avoid institutionalization and there is a written assessment by a licensed Physical Therapist, a registered Occupational Therapist, a vendored rehabilitation facility or Independent Living Center.

026	Intensive Transition Services	<p>A regional center shall classify a vendor as a provider of intensive transition services if the vendor is an agency which employs staff who possess the skill, training and education necessary to support individuals with complex service needs during the transition process from a highly restrictive setting to a less restrictive living situation in the community. Intensive services may also be provided to enable individuals to maintain a less restrictive living situation in the community when they are at high risk of being placed in highly restrictive settings.</p> <p>The scope of intensive transition services includes, but is not limited to, conducting risk assessments; developing comprehensive Person Centered Plans; making recommendations to planning teams, providing intensive preparatory services to individuals and their Interdisciplinary Teams, training and evaluation pre-transition and during transition as identified in the Individual Program Plan, supporting individuals with complex service needs during the transition process, and training families and community-based service providers.</p> <p>The services included within this service code shall be provided by transition teams that include three or more of the following professionals: Behavior Analyst, Nurse, Medical Doctor, Psychiatrist, Psychologist, Social Worker.</p>		
028	Socialization Training Program	A regional center shall classify a vendor as a Socialization Training Program service provider if the vendor provides socialization opportunities for school age developmentally disable persons. At a minimum the following should be provided: Adaptive recreation/socialization programs; Integration opportunities through the program's independent living skills activities; Access to public recreation and leisure facilities; Activities that will enhance and develop meaningful interpersonal relationships. Exclude programs Department of Education are required to fund.

029	START (Systemic, Therapeutic, Assessment, Resources and Treatment Services)	A regional center shall classify a vendor as a provider of START services if the vendor is an agency which employs staff who possess the skill, training, and education necessary to support individuals with mental health needs and has a program certification from the National Center for START Services or is implementing START services and is preparing to receive program certification from the National Center for START Services. START services may be provided to support an individual in crisis or who has complex behavioral, medical, and/or trauma-related support needs, to maintain a less restrictive living or working situation, to avoid in-patient admission, and/or assist after discharge from an in- patient or restrictive setting. The scope of this service includes, but is not limited to, conducting whole-person assessments; conducting comprehensive service evaluations; developing Cross-Systems Crisis Prevention and Intervention Plans; providing person-centered and trauma-informed case coordination; training individuals, family members, caregivers, and other professionals to implement proactive strengths-based behavioral strategies and prevent distressed behaviors; de-escalating an individual; providing emergency on-call supports 24 hours every day; and providing post-emergency follow-up.		
034	Money Management	A regional center shall use the Money Management service code if a regional center consumer requires skills training in money management.		
042	Repair Services	A regional center shall classify a vendor as a Repair Services Provider if the vendor provides services needed to maintain the home in a clean, sanitary and safe environment. This service includes heavy household chores such as washing floors, windows and walls, tacking down loose rugs and tiles, moving heavy items of furniture in order to provide safe access and egress, and minor repairs such as those which could be completed by a handy-person. These services will be provided only in cases where neither the individual, nor anyone else in the household, is capable of performing or financially providing for them, and where no other relative, care giver, landlord, community/volunteer agency, or third party payer is capable of, or responsible for, their provision. In the case of rental property, the responsibility of the landlord, pursuant to the lease agreement, must be examined prior to any authorization of service.		
048	Client/Parent Support Behavior Intervention Training	<b>This service code can no longer be used unless the Department approves an exemption.</b> A regional center shall classify a vendor as a Client/Parent Support/Behavior Intervention provider if the vendor provides behavior intervention services to include the use of behavior intervention programs, development of programs to improve the recipient's development, behavior tracking and analysis, and the fading of any intrusive intervention measures. The intervention programs will be restricted to generally accepted positive approaches. Program services ages 4 years to 18 years (or those 3 years or younger deemed high risk for developmental delay). This program is not funded by the Dept. of Education because children and families will be served on an individual basis. 051	Personal Emergency Response System (PERS)	A regional center shall classify a vendor as a Personal Emergency Response System provider if the vendor provides 24-hour emergency assistance service which enables, the recipient to secure assistance in the event of an emotional, physical, or environmental emergency PERS are individually designed to meet the needs and capabilities of the recipient and includes training, installation, repair, maintenance, and response needs. The following are allowable: 1. 24-hour answering/paging 2. Beepers; 3. Medical alert bracelets; 4. Intercoms; 5. Life-lines; 6. Fire/safety devices, such as fire extinguishers and rope ladders 8. Light fixture adaptations (blinking lights, etc.); 9. Telephone adaptive devices not available from the telephone company; and 10. Other electronic devices/services designed for emergency assistance. PERS services are limited to those individuals who have no regular care giver or companion for periods of time, and who would otherwise require extensive routine supervision. By providing immediate access to assistance. PERS services prevent institutionalization of these individuals. PERS services will only be provided as waiver service to individuals residing in a non-licensed environment. All items shall meet applicable standards of manufacture, design, and installation. Repairs to and maintenance of such equipment shall be performed by the manufacturer's authorized dealers where possible.		
055	Community Integration Training Program	<b>This service code can no longer be used unless the Department approves an exemption.</b> A regional center shall classify a vendor as a Community Integration Training Program provider if the vendor provides community integration training that includes, but is not limited to, assistance with acquisition, retention, or improvement in self-help, socialization and adaptive skills which take place in a non-residential setting, separate from the home or facility in which the consumer resides. Services shall normally be furnished 4 or more hours per day on a regularly scheduled basis, for 1 or more days per week unless provided as an adjunct to other day activities included in a consumer's IPP. Community integration training shall focus on enabling the consumer to attain or maintain his or her maximum functional level and shall be coordinated with any physical, occupational, or speech therapies listed in the IPP. 073	Parent Coordinated Supported living Program	A regional center shall classify a vendor as a Parent Coordinated Supported Living Program vendor if the vendor promotes and reinforces social behavior and skill levels through paid staff, housemates, family and friends.  Use of this service code requires prior approval by the Department.		
074	Out-Of-Home Respite-Acute Care Facility	Provides out-of-home respite services, which consist of intermittent or regularly scheduled temporary care to individuals in an acute care facility.		
076	Coordinated Family Support (CFS) Services Pilot Program	Coordinated Family Support (CFS) Services Pilot Program: A regional center shall classify a vendor as a CFS provider when the vendor coordinates and provides items identified below for adults who reside in the family home. CFS shall be tailored to the unique needs of the consumer and their family and provided in a manner that respects their language and culture. It shall be primarily provided in a person's home. CFS may include, but is not limited to: 1. Identifying and providing supports necessary to successfully reside in the family home; 2. Providing assistance and training for the consumer and their family in navigating comprehensive services and supports that are tailored to meet their unique needs, including creating pathways to overcome barriers to accessing generic and other resources; 3. Providing additional information or resources on the consumer's diagnosis and identified supports; 4. Coordinating consistency in training across providers specific to the needs of the consumer and their family; 5. Assisting with scheduling of service delivery including medical and other appointments; 6. Identifying transportation options or services; 7. Identifying backup providers/supports and providing those backup supports when the plan fails; 8. Providing futures planning for the consumer, including those living with aging caregivers; 9. Providing training to the consumer which maximizes their independence. CFS shall not replace or duplicate any regional center service coordination, generic service or other regional center funded service that the consumer and their family are receiving. CFS may not be provided by an individual who resides in the same home as the consumer. At minimum, the need shall be assessed annually, with progress being reported quarterly. Minimum qualifications for CFS staff include an Associates-level degree in a human services field of study or 3 years of experience in the developmental disabilities service delivery system, communicating in the primary language of the consumer and their family, and knowledge of the regional center system. CFS Supervisor qualifications require a Bachelors-level degree in a human services field of study or an Associates level degree in a human services field of study and at least 3 years of experience in the developmental disabilities service delivery system. Within the first 30 days of working with a consumer and their family, CFS providers shall provide training to their staff and supervisors on the service delivery systems including, but not limited to, behavioral health services and local Area Agencies on Aging. 084	Special Olympics	A regional center shall classify a vendor as a Special Olympics provider if the vendor provides training and ensures consumer participation in the Special Olympics.		
089	Housing Access Services	Includes two components: A) Individual Housing Transition Services – These services provide direct support and assistance with activities and processes associated with an individual's preparation for and transition to housing. These services are: 1) Conducting a tenant screening and housing assessment that identifies the participant's preferences and barriers related to successful tenancy. The assessment includes collecting information on potential housing transition barriers, and identification of housing retention barriers. 2) Developing an individualized housing support plan based upon the housing assessment that addresses identified barriers, includes short and long-term measurable goals for each issue, establishes the participant's approach to meeting the goal, and identifies when other providers or services, both reimbursed and not reimbursed by Medicaid, may be required to meet the goal. 3) Assisting the individual with the housing application process. Assisting with the housing search process. 4) Assisting the individual with identifying resources to cover set-up fees for utilities or service access, including telephone, electricity, heating and water, and services necessary for the individual's health and safety, consisting of pest eradication and one-time cleaning prior to occupancy. 5) Assisting the individual with coordinating resources to identify and address conditions in the living environment prior to move-in that may compromise the safety of the consumer. 6) Assisting the individual with details of the move including communicating with the landlord to negotiate a move-in date, reading and understanding the terms of the lease, scheduling set-up of utilities and services, and arranging the move of consumers' belongings. 7) Developing a housing support crisis plan that includes prevention and early intervention services when housing is jeopardized. B) Individual Housing & Tenancy Sustaining Services – This service is made available to support individuals to maintain tenancy once housing is secured. The availability of ongoing housing-related services in addition to other long term services and supports promotes housing success, fosters community integration and inclusion, and develops natural support networks. These tenancy support services are: 1) Providing the individual with early identification and intervention for behaviors that may jeopardize housing, such as late rental payment and other lease violations. 2) Providing the individual with education and training on the role, rights and responsibilities of the tenant and landlord. 3) Coaching the individual on developing and maintaining key relationships with landlords/property managers with a goal of fostering successful tenancy. 4) Assisting the individual in resolving disputes with landlords and/or neighbors to reduce risk of eviction or other adverse action. 5) Providing the individual with advocacy and linkage with community resources to prevent eviction when housing is, or may potentially become jeopardized. 6) Assisting the individual with the housing recertification process. 7) Coordinating with the tenant to review, update and modify their housing support and crisis plan on a regular basis to reflect current needs and address existing or recurring housing retention barriers. 8) Providing the individual with continuous training in being a good tenant and lease compliance, including ongoing support with activities related to household management.  Housing Access Services do not include payment for room and board. Persons receiving Health Homes or California Community Transitions services will not receive this service unless additional Housing Access through the waiver is necessary to maintain the consumer's health, safety and wellbeing in the home and/or community.

Payment of crisis intervention facility services does not include room and board.		
091	In-Home Day Program	A regional center shall classify a vendor as an In-Home Day Program Provider if the vendor provides day program services to consumers who are unable to attend day programs outside their homes, because of medical conditions that prevent travel to outside programs. In home day programs are designed to allow the consumer to remain in a stable day program environment. In-Home Day Program services include, a variety of activities designed to meet consumer needs from activity center programs to vocational activities that can be completed from home. An In-Home Day Program must be vendored with the regional center and have a regional center approved program design that includes the provision for an annual assessment process to ensure consumer participation in this type of program remains appropriate. 094	Creative Art Program	A regional center shall classify a vendor as a Creative Arts Program provider if the vendor provides a program that facilitates self-expression through art, which includes art classes, the development of vocational skills.		
096	Geriatric Facility	A regional center shall classify a vendor as a Geriatric Facility provider if the vendor operates a residential facility for the elderly. Geriatric Facility services include, but are not limited to, personal care and services, homemaker, chore, attendant care, companion services, medication oversight (to the extent permitted under State law), therapeutic social and recreational programming, provided in a home-like environment in a licensed (where applicable) community care facility or family home certified by a family home agency, in conjunction with residing in the facility. This service includes 24-hour onsite response staff to meet scheduled or unpredictable needs in a way that promotes maximum dignity and independence, and to provide supervision, safety and security. Other individuals or agencies may also furnish care directly, under arrangement with the community care facility, but the care provided by these other entities supplements that care provided by the community care facility and does not supplant it. A Geriatric facility service may also include, home health care, physical therapy, occupational therapy, speech therapy, medication administration, intermittent skilled nursing services, or transportation specified in the plan of care. The regional center shall vendor the geriatric facility in accordance with Title 17, CCR, §54310 and 5432, Health and Safety Code §1500-1569.87; and Title 22, CCR, §§87100-87730.		
097	Wellness Initiative Projects	Varied projects approved by the Department through the Wellness Initiative Request For Proposal (RFP) process to promote the health and well-being of all Californians with developmental disabilities.		
099	Self-Directed Support Services	General Self-Directed Supports (General SD Supports) occur after a potential participant completes a Self-Determination Program (SDP) orientation and before enrollment in the SDP. Providers of General SD Supports must meet distinct vendor qualifications. The General SD Supports vendor packet is available here. Regional centers may authorize General SD Supports for up to 40 hours following receipt of written information about the proposed services, estimated hours, and service cost. 101	Housing Services	A regional center shall classify a vendor as a Housing Services provider if: The vendor provides or brokers housing-related services identified in the consumer's IPP, integral to the consumer achieving and/or maintaining a home. Housing Services include, but are not limited to: moving, storage, utility services (such as electricity, gas, water, telephone etc.), property management, and/or the location of subsidized or other types of affordable housing.		
102	Individual or Family Training	A regional center shall classify a vendor as a Individual or Family Training provider if the vendor provides, or obtains, training services to consumers and/or their family members as necessary to implement an objective in the individual's IPP and for which an existing Title 17 service code is unavailable, including, but not limited to training regarding: prevention of sexual exploitation, parent and family support training to avert out-of-home placement. Individual or family training may include refresher training, as necessary to facilitate a safe, harmonious and stable home, and may be provided in groups, e.g., seminars and symposiums, or on an individual basis. Vendors shall ensure that trainers are credentialed and/or licensed as required by the State of California to practice in the field of training being offered.		
103	Specialized Health, Treatment and Training Services	<b>This service code can no longer be used unless the Department approves an exemption.</b> A regional center shall classify a vendor as a Specialized Health, Treatment and Training Services provider if the vendor provides, or obtains, health or dental services for which there is not an existing Title 17 service code, and that is deemed necessary by a health care professional to implement an objective in the consumer's IPP. Specialized Health, Treatment and Training Services include, but are not limited to: services that increase or maintain health, gastrostomy and care of G-Tube treatment for mental illnesses and/or chemical dependencies, dental hygiene training for consumers and care providers, and the shipment of medical samples for testing. Vendors shall ensure that trainers are credentialed and/or licensed as required by the State of California to practice in the field of training being offered. 104	Environmental Accessibility	A regional center shall classify a vendor as a Environmental Accessibility Provider if: The vendor provides adaptations to the consumer's home as needed to implement an objective in the individual's IPP. Environmental Adaptations shall be deemed necessary to ensure the health, welfare and safety of the consumer, and/or enable the consumer to function with greater independence in their home, without which the consumer would require institutionalization. Such adaptations may include the installation of ramps and grab bars, widening of doorways, modification of bathroom facilities, or installation of specialized electric and plumbing systems necessary to accommodate the medical equipment and supplies necessary for the welfare of the consumer. Excluded are those adaptations or improvements to the home that are of general utility, and are not of direct medical or remedial benefit to the individual, such as carpeting, roof repair, central air conditioning, etc. Adaptations that add to the total square footage of the home are excluded from this benefit. All services shall be provided in accordance with applicable State or local building codes. The individual or agency providing the environmental modification shall possess a current license, certification, or registration with the State of California as appropriate for the type of modification being purchased. The provider shall also possess a current license to do business, issued by the local jurisdiction within which the individual or agency is located and provides the services.		
105	Travel Reimbursement	A regional center shall classify a vendor eligible for Travel Reimbursement if travel services, e.g., travel agency services, tickets, per diem and lodging costs are incurred while implementing provisions related to a consumer's Individual Program Plan (IPP) and if the vendor is: (A) A travel agency and operates a business for the purpose of providing travel services, tickets and travel vouchers or; (B) A person or service provider authorized by the regional center to recover travel costs, per diem and lodging.
